Explain: The segments upstream from unnamed tributary 2 (UT-2) are unnamed upland drains that are approximately 1,100, 800 and 400 feet in length. After inspecting the site, we determined that these three drains were erosional features and did not exhibit a defined bed, bank or ordinary high water mark; therefore, they are not jurisdictional under Section 10 of the Rivers and Harbors Act or Section 404 of

the Clean Water Act. This site is located in the Ozark Mountains and the topography here basically consists of steep ravines that eventually transition into narrow floodplains between the mountains. The watershed of each drain is fairly small. These drains do transport surface water during rain events, but do not have sufficient characteristics to meet the jurisdictional requirements under the Clean Water Act.

#### **B. Characteristics of Tributary (That Is Not a TNW) and Its Adjacent Wetlands (If Any):**

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION**

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** UT-2 is approximately 2,400 linear feet in length and has a watershed or drainage area of approximately 35 acres. There is a cave/seep located along UT-2 in Addition B and a small impounded pond in Addition A. There is a small rookery located on the pond. We determined that the three segments of UT-2 upstream from the seep are not jurisdictional streams. They did not exhibit a defined bed, bank or ordinary high water mark, and leaf litter from last fall was still in the drain. These uppermost segments are

approximately 1,100, 800 and 400 feet in length, respectively. According to the Jurisdictional Determination Guidebook, they are erosional features or swales.

The lower segment of UT-2 is a jurisdictional Relatively Permanent Water. This lower segment is approximately 1,200 feet in length and exhibits intermittent flows along its entire length. Near the cave/seep we noted intermittent pools of water and a bed and bank, and consistent scour, debris piles, etc. We also noted flow from the pond outlet to the railroad tracks. The pond was constructed many years ago by excavating and constructing a small dam. The pond is approximately 0.6 acres in size.
