This letter is in regard to your request for a Special Events Permit on Table Rock Lake: Reference Missouri Water Patrol Regatta Permit No. _____. (If you have not yet applied for a Regatta, you may obtain an application by contacting the Missouri State Water Patrol, Jefferson City at (573) 751-3333 or visit www.mswp.dps.mo.gov.)

We are forwarding a copy of our Special Events Application that must be completed in its entirety before your request can be approved. We ask that you either type or print clearly. Please be sure to indicate the number of participants (including the total number of boats), spectators, officials, and the anticipated revenue/expense portions. If these items are not completed, your Special Events Application will be returned. In the event that your application is returned, and there is not sufficient time for re-submittal, your request could be denied.

All events that are held at a Corps maintained area and involve more than 25 persons will be required to pay a minimum non-refundable Special Event Permit fee of \$50.00. Tournament events that involve 13 boats or more are typically subject to this fee (we base this on the calculation of a two-man boat). If a fee is required, please submit a check or money order made payable to FAO, US Army, LRD, along with the completed Special Events Application. If no fee is required, you still must return the completed application. Failure to submit all required information, including application and payment, at least seven (7) days prior to the event may result in the denial of the request. The Missouri State Water Patrol will also be informed of the cancellation.

Fishing within 50 feet of marina docks is prohibited. Any violations of this policy by a tournament participant may result in disapproval of the special event permit for the tournament in the future.

The next page designates the maximum number of boats that will be permitted to participate in an event at each of the Corps of Engineers maintained areas (Appendix B). If the number of boats in your event exceeds the limitations of the requested area, special conditions may be required. Please notify our office regarding any event that may exceed the limits indicated for an area.

APPENDIX B

BOAT LIMITATIONS FOR RECREATION AREAS

Due to traffic and parking congestion resulting from the over-use of public recreation areas, the following criteria will be applied limiting the maximum size of the event.

SPECIAL EVENT PERMIT CONDITIONS

1. Admission to the area where the event will be held must not be limited to membership of the sponsoring group, nor will any discrimination be made against a person because of race, creed, sex, or national origin in conducting activities.
2. No costs will accrue to the Government.
3. Permittee will make necessary provisions that the activity will not preempt the public use of the project recreational resources.
4. The permit request must be in accordance with applicable Federal, state and local laws.
5. The United States Government is not responsible for damage to property or injury to persons attending the event. The permittee will be responsible for health and safety requirements of participants and spectators. Proof of insurance coverage may be required as one of the conditions of this permit. When required, such proof must be furnished to the Resident Engineer/Manager at least 5 days prior to the event or the permit is null and void.
6. The permittee shall save and hold the United States harmless from any and all claims for damages to property and injuries to persons, which may arise or be incident to the event.
7. The right to charge will be based on the provision of parking assistance, adequate policing for crowd supervision and control, and other services to be provided by the requesting organization. A schedule of fees, if any, to be charged the public must be furnished and approved prior to the event.
8. Collections, if any, in excess of actual total costs will be considered as lease-hold to be paid to the Corps of Engineers for legal disposal except if surplus proceeds are used for purposes which would benefit public use of the project. Donations to recognized charities and the cost of trophies and other awards may be considered costs of the event.
9. Concession permits will be granted to the permittee only in the absence of a commercial concession lease in the area or with written approval of the commercial concessionaire.
10. The permittee will establish and maintain adequate records and accounts of receipts and expenditures and shall make such records and accounts available upon request. The Government reserves the right to audit the sponsor's records.
11. The permitted site will be fully restored to pre-use conditions by the permittee within 48 hours after the event closes or as directed by the Resident Engineer/Manager at the project.
12. A Performance Bond in the form of a check or money order made payable to the "FAO, Little Rock," may be required as one of the conditions of this permit to cover potential damages and maintenance costs. It is understood that the performance bond will be returned to the sponsoring organization when the area has been fully restored to its pre-use condition. The performance bond must be furnished to the Resident Engineer/Manager at least 5 days prior to the event or the permit is null and void.
13. The activity will be of a limited duration, generally not more than an 8-hour period at any one time; however, the permit will be limited to 4 days with holiday use considered on a case-by-case basis.
14. All boating events held on Corps of Engineers lakes in the State of Missouri require concurrent approval of the Missouri Division of Water Safety.
15. Other conditions may be added to the permit as required.

PREVIOUS EDITIONS ARE OBSOLETE

Your group/organization has a Special Event proposed/scheduled on Table Rock Lake. The US Army Corps of Engineers will be collecting recreation user fees at: Aunts Creek, Baxter, Big M, Campbell Point, Cape Fair, Cricket Creek, Eagle Rock, Indian Point, Long Creek, Mill Creek, Moonshine Beach, Old Highway 86, Viney Creek, and Viola. **For ALL recreation areas an Area Use Fee of \$4 per vehicle will be charged.**

This Area Use Fee will be in addition to the \$50.00 Special Events permit that applies to special events involving more than 25 persons. Please notify all participants in your event of this additional fee. This fee is required at **ALL** times without regard to whether the Recreation Area is open or closed or whether the booth has an attendant on duty. An honor vault, with payment envelopes, is provided at each of the above noted Recreation Areas for the remittance of Area Use fees at times in which the booth is unattended.

This fee will not apply to those participants who have purchased a US Army Corps of Engineers Annual Pass. An Annual Pass may be purchased for \$30.00 to permit the holder and accompanying passengers to use recreation areas at Corps-operated areas (Nationwide) without further charges. Golden Age, Golden Access, America the Beautiful Senior and America the Beautiful Access Passports will be honored. These pass holders will be eligible to purchase the \$30.00 Annual Pass for half price or pay half of the applicable fee. Those who have an Annual Pass **MUST** display this pass in their vehicle in order to avoid an additional launch fee. (Please see the next section of this letter for information in obtaining an Annual Pass.)

The Corps already charges camping fees and reservation fees for Corps of Engineers campgrounds. Campground users will not pay area use fees in addition to camping fees. The Corps was given authorization to collect area use fees in recent deficit reduction legislation, the Omnibus Budget Reconciliation Act of 1993 (Public Law 103-66). The funds will be used to help pay operations and maintenance costs in the Corps Recreation Program.

ANNUAL DAY USE PASSES MAY BE PURCHASED:

1) **In Person** at the Table Rock Lake Project Office – located on Highway 165 next to Table Rock Dam (adjacent to the Dewey Short Visitor Center). Office hours are Monday through Friday, 7:30 A.M. – 4:00 P.M. *Note:* Annual Passes will be available for purchase during posted booth hours at the Table Rock Lake Recreation Areas and the Dewey Short Visitor Center, upon their spring opening dates.

Information required in order to purchase a pass:

- 1) Name of individual it is issued to.
- 2) State and license plate number of the subject vehicle. Annual Pass stickers are displayed on the vehicle **not** the boat nor boat trailer.
- 3) Check or money order made payable to: FAO, US Army, LRD.
- 4) Credit card orders require Visa or MasterCard number and the expiration date of the card.
- 5) Be sure to include the proper mailing address for the return of all mail orders.

COST FOR ANNUAL DAY USE PASSES - \$30.00

PURCHASES MADE WITH A GOLDEN AGE, GOLDEN ACCESS, AMERICA THE BEAUTIFUL SENIOR OR AMERICA THE BEAUTIFUL ACCESS PASSPORTS MUST BE MADE IN PERSON IN ORDER TO QUALIFY FOR THE FIFTY PERCENT (50%) DISCOUNT.

Area Use Fee payments may also be made in the following manner:

- 1) Pay the Attendant on duty during booth operating hours. You will be issued a boat launch permit to be displayed in your vehicle.
- 2) Remit payment at the honor vault (located next to the Park Attendant Booth – envelopes provided). Display payment receipt on the dashboard of your vehicle.

AREA USE FEES MUST BE PAID REGARDLESS OF WHETHER THE RECREATION AREA IS OPEN OR CLOSED – FAILURE TO PAY THE APPROPRIATE AREA USE FEE AT THE HONOR VAULT WHEN THE BOOTH IS UNATTENDED MAY RESULT IN THE ISSUANCE OF A NOTICE OF VIOLATION.
