The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. Summarize overall biological, chemical and physical functions being performed: The entirety of the wetland areas were observed to be early successional for both the abutting and adjacent wetlands. These wetland areas supported little aquatic and wildlife values, and appeared to exhibit limited wetland functionality for both flood storage and wildlife habitat.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

- Does the tributary, in combination with its adjacent wetlands (if any), have the capacity to carry pollutants or flood waters to TNWs, or to reduce the amount of pollutants or flood waters reaching a TNW?

- Does the tributary, in combination with its adjacent wetlands (if any), have other relationships to the physical, chemical, or biological integrity of the TNW?

B. ADDITIONAL COMMENTS TO SUPPORT JD: In summary, a 3.9-acre pond/impoundment which was excavated from Waters of the U.S. were determined to be jurisdictional. Additionally, the subject stream within the project area (520 linear feet) was found to be a RPW in that it has seasonal flow. The subject wetlands on-site were also found to be jurisdictional. 0.05-acre of the 0.25 acre wetlands total was determined to be abutting wetlands to an RPW. The remaining 0.20-acre of wetlands were determined to be adjacent to an RPW, but were also found to have a significant nexus to the TNW which in this instance which would be the Arkansas River. Supporting data for all of these determinations are found within this form as well as within the available supporting data information outlined in Section IV of this form.
