wetland indication does not extend to the southern boundary of the existing wooded area. The field examination accomplished by the NRCS also indicates that this narrow strip is non-wetland. The Web Soil Survey indicates that there are 2 hydric soils in this narrow strip. The existing ditch is considered a field ditch because it is not present on the topographic map nor is it on the County Soil Survey. Although this area does have mapped hydric soils, the NWI map clearly indicates the wooded area to the north is not entirely wetland. In particular this narrow area is not wetland.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
