This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. Identify specific pollutants, if known: Big Creek flows into the Current River some 6.7 miles upstream of this project. There is a sand and gravel operation located on Big Creek. However it is not believed that this action is contributing to the gravel issue that the Ozark National Scenic Riverways is experiencing at Akers Ferry. The USGS published a study in 2001 (BSR-2001-0005) where they determined that the gravel present in this watershed was the result of historical land use effects rather than current practices.

Aquatic/wildlife diversity. Explain findings: The Nature Conservancy published a study in November 2003, titled the Ozarks Ecoregional Conservation Assessment. In this study they found that the Current River was probably the most significant middle sized river in midcontinental North America. The river hosts 35 endemic or modal species and 25 of these species have their best, most viable, populations globally in this river. Threats that were identified include conversion of private forest lands to pasture and rural residential development and sedimentation from development in the watershed.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
