#### B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. Summarize overall biological, chemical and physical functions being performed: The wetlands occur either abutting or adjacent to Henslee Creek. Wetland A abuts Henslee Creek and the remainder of the wetlands ( H, D, B, C) are adjacent to Henslee Creek. The wetlands likely provide habitat and cover for wildlife species and provide natural aquatic habitat that replace some of the biological characteristics associated with the former stream that is now a concrete lined channel. The wetlands provide flood storage retention within the site. Wetland H likely retains water that would otherwise sheetflow over the adjacent highway.

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:**

Wetland B occurs within the mapped 100-year floodplain which would likely be flooded when Henslee Creek overtops its banks; portions of this wetland could be categorized as the historical channel of Henslee Creek.

During the dry season site visit, the consultant’s report identified water within Henslee Creek. The abandoned channel likely carries overflow water from Henslee Creek. Wetland A directly abuts Henslee Creek. Wetland B likely replaces the historical channel of Henslee Creek which provides the hydrological connection between the two tributaries.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** This jurisdictional determination was completed for two seasonal relatively permanent tributaries (Henslee Creek and its abandoned channel) and seven wetlands. Two of the wetlands (G and F) were determined to be isolated. Five of the wetlands (A, B, C, D, and H) were determined to be jurisdictional waters of the US. Wetlands B, C, D, and H, are adjacent to the tributary and are considered to have a significant nexus to a TNW (Arkansas River). Wetland A is abutting Henslee Creek.
