This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. The channel appeared to be continuous from the up stream pond to Pike Creek and the appearance of the channel supported an infrequent flow (ephemeral), as observed during site visit on 25 October 2010, as opposed to a continuous flow for any length of time (intermittent).

Other information on duration and volume: The number of flow events was supported by the average CN (soil type/landuse) and rainfall data over several years.

Explain: The area was very dry during my field visit, so no water was observed in the tributary. There are several homes along this unnamed tributary, but there is a large percentage of timber and undisturbed leaf litter providing a great deal of water retention.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

These 2 ponds provide diverse habitat in close proximity to Pike Creek. The above text supports that there is a significant nexus between this unnamed tributary and the ponds to the downstream Black River, which is the TNW of this watershed.

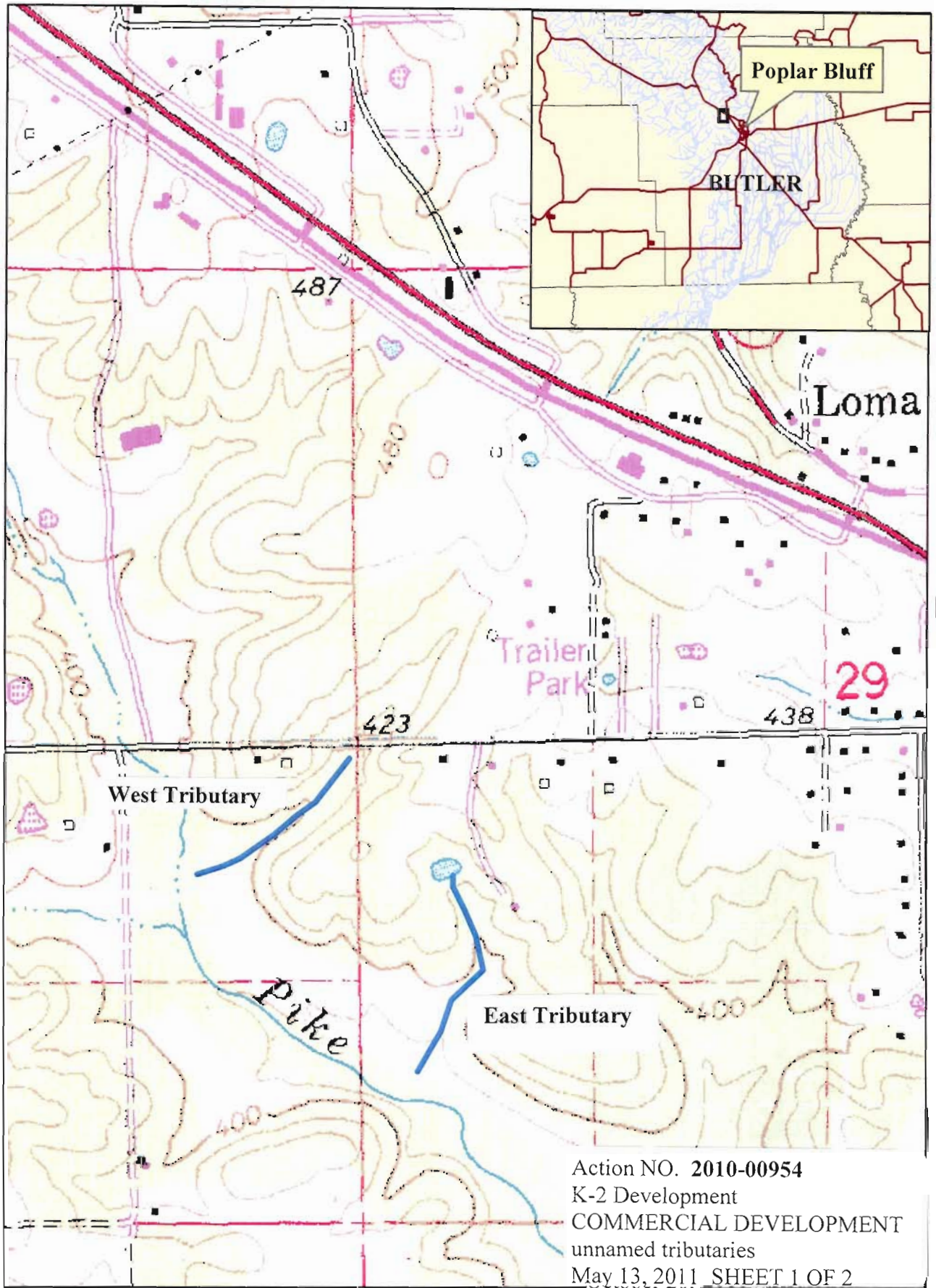

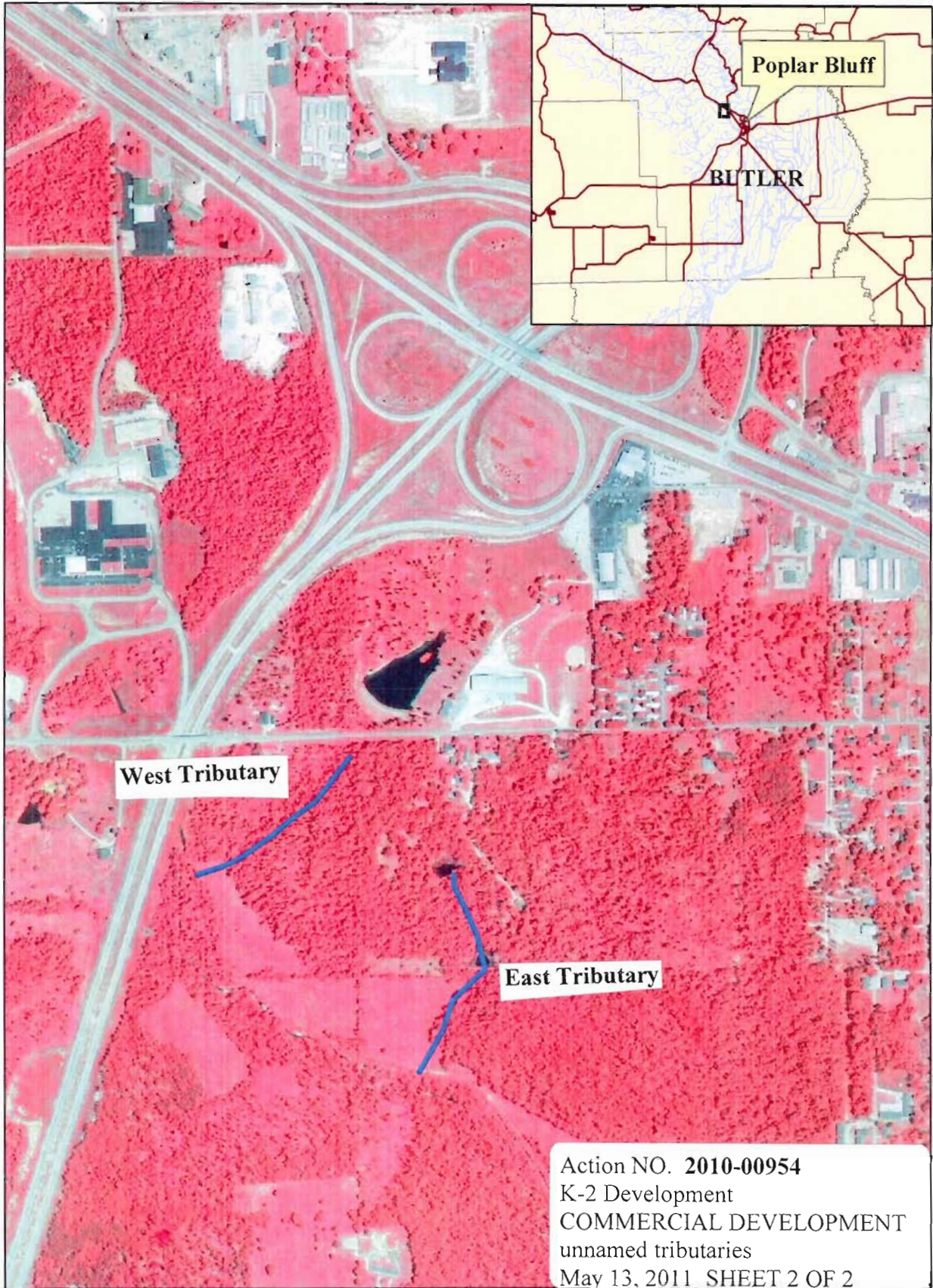
B. ADDITIONAL COMMENTS TO SUPPORT JD: During rain events this unnamed tributary transports organic material such as leaves and woody debris from the riparian forest into the 2 small ponds and into the perennial water column of Pike Creek. This feeds macro-invertebrates of Pike Creek (RPW) and the Black River, a Section 10 waters as classified by SWL (TNW). These rain events would also be capable of carry pollutants into Pike Creek. This unnamed tributary provides ephemeral flows that fill 2 small ponds and discharge water over a spillway. The floating vegetation in the 2 ponds provide refuge for small fish and amphibians; the lower pond is within 700 feet of Pike Creek and the upper pond within 1,200 feet. These 2 ponds provide diverse habitat in close proximity to Pike Creek. The above text supports that there is a significant nexus between this unnamed tributary and the two ponds to the downstream Black River, which a TNW of this watershed.
