Col. Kenneth N. Reed Commander, Southwestern Division

Colonel Kenneth N. Reed is the Commander and Division Engineer of the Southwestern Division, U.S. Army Corps of Engineers. The Division, which is headquartered in Dallas, is one of nine Corps of Engineers regional commands. With four District Offices in Little Rock, Arkansas; Tulsa, Oklahoma; and Galveston and Fort Worth, Texas, it encompasses all or part of six states, and covers some 2.3 million acres of public land and water. As the SWD Commander and Division Engineer, Reed oversees hundreds of water resources development and military design and construction projects that bring value to our communities, our Nation, and our warfighters. Prior to coming to SWD, Reed served as the Commander for the U.S. Army Corps of Engineers Fort Worth District in Texas and Transatlantic Expeditionary District in Kuwait.

Reed held a variety of leadership and staff positions throughout his career at the tactical, operational, and strategic levels. His early leadership assignments began with the 23rd and 16th Engineer Battalions in Germany, serving as a Sapper and Support Platoon Leader, Company Executive Officer, and Battalion Maintenance Officer during Operation Joint Endeavor and Operation Joint Guard, Bosnia. He joined the 4th Infantry Division at Fort Hood, Texas, serving in multiple staff and command positions culminating as Company Commander during Operation Iraqi Freedom. Reed served as the Battalion Executive Officer Observer, Controller, and Trainer for the 1st Battalion, 395th Regiment (EN). His field-grade leadership assignments began as a Military Transition Team Chief for the 9th Brigade, 3rd Iraqi Army Division in Al Kisik, Iraq, followed by key developmental assignments in the 36th Engineer Brigade at Fort Hood, Texas, and Afghanistan. He served as the Aide-de-Camp for the USACE Commanding General in Washington, DC, until being selected to command the 20th Engineer Battalion, Fort Hood, Texas. Reed attended Senior Service College at the National Defense University's Joint Advance Warfighting School in Norfolk, Virginia, with a follow-on utilization tour at U.S. European Command in Germany, serving as the Future Operations Branch Chief.

Reed is a native of Louisville, Alabama. He received a commission in the U.S. Army Corps of Engineers after graduating as a Distinguished Military Graduate from the University of Alabama in December 1995. He holds a bachelor's degree in Civil Engineering from the University of Alabama and master's degrees from the University of Missouri at Rolla in Engineering Management, from the National Defense University in Joint Campaign Planning and Strategy. He also holds the Project Management Professional certification. Reed's awards and decorations include the Legion of Merit, Bronze Star, Defense Meritorious Service Medal, Meritorious Service Medal, Navy/Marine Corps Commendation Medal, Army Commendation Medal, Humanitarian Service Medal, Army Achievement Medal, Combat Action Badge, Parachutist Badge, and Army Engineer Association's Bronze and Silver Orders of the de Fleury Medal. His operational deployments include Operation Joint Endeavor and Operation Joint Guard in Bosnia, Operation Iraqi Freedom, and Operation Enduring Freedom.



Colonel Damon Knarr Little Rock District U.A. Army Corps of Engineers

Colonel Damon M. Knarr assumed duties as District Engineer and Commander of the U.S. Army Corps of Engineers Little Rock District on July 12, 2022. He came to Little Rock from U.S. Army Central Command, where he served as the 3rd Army Engineer Director.

Colonel Knarr graduated in 1998 with a bachelor's degree in Criminal Law from Florida State University in Tallahassee, Florida where he also earned his commission through the university's Department of Military Science Reserve Officer's Training Corps. After earning his Master of Business Administration Degree from Webster University he taught Operational Design at the Joint and Combined Warfighting School and

is an alumnus of the International Strategic Studies Fellowship at Tufts University's Fletcher School of Law and Diplomacy.

Knarr has served in a variety of operational, command and staff assignments in the United States and overseas. His previous assignments include Brigade Personnel officer, Brigade Construction Officer, and Battalion Logistics Officer during Operation Iraqi Freedom from 2003-2004 and as the Assistant Brigade Engineer for 1st Brigade Combat Team, 1st Armored Division and Company Commander of B Company 16th Engineer Battalion during Operation Iraqi Freedom from 2006-2007. Other operational assignments include Battalion Operation and Executive Officer for the 5th Engineer Battalion, 1st Maneuver Enhancement Brigade from 2010-2012, working in NATO as the Engineer Intelligence Officer in the Rapid Reaction Corps in France from 2012-201 S. From there he went on to command the 299th Brigade Engineer Battalion, 1st Stryker Brigade Combat Team, 4th Infantry Division from 2015-2017. Following his battalion command, he joined the military faculty at the Joint and Combined Warfighting School from 2018 to 2020.

He is a graduate of the Engineer Officer Basic and Advanced courses, Combined Arms Services Staff School, Army Command and General Staff College, the NATO Intel Planner's Course, Forced Entry Tactical Training Course, and is a Joint Services Qualified Planner.

His military awards include a Legion of Merit, Bronze star Medal with one oak leaf cluster, Defense Meritorious Service Medal with one oak leaf clusters, Army Commendation Medal with one oak leaf cluster, Army Achievement medal with two oak leaf clusters, Army Presidential Unit Citation, Joint Meritorious Unit Award, National Defense Service Medal, Iraq Campaign Medal, Global War on Terrorism Expeditionary Medal, Global War on Terrorism Service Medal, Korea Defense Service Medal, Overseas service Ribbon with three oak leaf clusters and the Kuwait Liberation Medal. He has also been awarded the Combat Action Badge, Parachutist Badge, and the Army Joint Chiefs of Staff Identification Badge.



Jonathan J. Sawrie Little Rock District Contracting Chief

Mr. Jonathan J. Sawrie assumed his role as District Contracting Chief for the Little Rock District in March 2021. Mr. Sawrie began his career with the Little Rock District in 1984 as a part-time student aid at the Toad Suck Ferry Project Office. In 1992 he accepted a permanent appointment as a Purchasing Agent supporting the MKARNS navigation, hydropower, recreation, and environmental stewardship missions. In 2009 Mr. Sawrie entered the Department of the Army Intern Program as a Contract Specialist in the District's Medical Support Branch. Shamekia M. Chapman District Chief Galveston District

Mrs. Shamekia M. Chapman serves as the District Chief of of Contracting U.S. Army Corps of Engineers Galveston District, a position she assumed in July 2021. A 16-year USACE veteran, Ms. Chapman currently oversees the acquisition planning, execution, and oversight of all contracts awarded in the Galveston District. Contracts range from horizontal construction of civil works projects such as maintenance dredging, channel deepening, levee repair/replacements, pump stations, and eco restoration to hydro/topographic surveys, design support, grounds maintenance and janitoral services and more at about \$400M per year. She also leads a team that is tasked with executing a \$7B Horizontal Construction MATOC and \$775M Architect-Engineer Services MATOC, two of the largest acquisition tools in USACE. During her time in the BOB, she was responsible for policy development and implementation, compliance reviews, developing and managing the divisions budget, training and career field certification, the GPC program, and document reviews. In addition, Ms. Chapman was integral in the district gaining back its contracting authority separate from the Ft. Worth District and standing up the Galveston Contracting Division after an 8-year hiatus. With her assistance the Division grew from a Branch of 5 to a division of 18.

She has been a USACE employee since 2006. Her background consists of extensive experience within the Corps of Engineers, ranging from Deputy for Small Business Programs at SWG; a SCO-DAL Procurement Analyst; Supplies and Services Section Chief, MEDCOM Support Team Contracting Officer, and Contract Specialist at the Mobile District; Cost/Price Analyst at Ft. Hood Army Contracting Command; and a Contract Specialist for the UPH furniture Program, MRR/FRR, and OMEE programs at Huntsville Engineering and Support Center.
