**OFF-ROAD VEHICLES AND ATV'S ARE PROHIBITED FROM CORPS OF ENGINEERS PROPERTY**

**PERMIT CONDITIONS AND REQUIEMENTS:**

This special camping permit program has been established to allow overnight camping in undeveloped sections of the public lands around the Corps of Engineers lakes. The permit is issued as a privilege to those campers who agree to take care of the natural environment in the area used. The applicant for a special camping permit agrees to the following conditions and requirements:

1. That the United States shall not be responsible for damages to property or injury to persons which may arise or be incident to the exercise of the privileges granted by the permit. The permittee will be responsible for taking all necessary precautions for the health and safety of the participants.
2. That the campsite shall be located in the area(s) designated and on the date(s) specified.
3. That the operation and parking of motor vehicles is restricted to approved roads, trails, and parking areas. Access to camping shall be by public roads or boats. **OFF-ROAD VEHICLES AND ATV'S ARE PROHIBITED.**
4. That the permittee shall keep the camp area free of refuse, garbage and trash at all times. Upon departure, the permittee shall remove all refuse, garbage and trash from the area and dispose of it properly.
5. That the permittee shall ensure all human wastes are disposed of properly in accordance with state and local laws and regulations.
6. That all fires shall be confined to portable facilities designed for the purpose and provided by the permittee. Fires shall not be left unattended. Ashes shall not be dumped on the ground.
7. That the permittee and party shall comply with all provisions of Part 327, Chapter III, Title 36, CFR. (Copies are available from Corps of Engineers)
8. An approved camping permit must be obtained in advance of camping on the Project at any location outside the developed parks.
9. The permit must be signed and in possession of the permittee at the site or visibly displayed on the equipment at the site.
10. Camping permits must be obtained and signed by the person in whose name the permit is to be issued and who shall be present and occupy the site overnight.
11. A separate camping permit shall be obtained for each camping unit.
12. In the event the local state conservation department declares the fire potential to be "VERY HIGH" or "EXTREME", primitive camping permits will not be issued. In addition, any time the local state conservation department declares the fire potential "EXTREME", all approved permits shall be rescinded.

**PRIVACY ACT STATEMENT (5USC 552a):**

1. Authority: Section 4, Act of December 22, 1944, 54 Stat 899, as amended 16 USC 460d; Public Law 90-483, 82 Stat 746; and Public Law 92-247, 86 Stat 459.
2. Principle Purpose: To provide a request for and authorization of special primitive or wilderness camping.
3. Routine Uses: This form is used by the Project Office to permit camping outside developed public use areas. The form is also used to assist the park manager in locating campers in the event of an emergency.
4. Mandatory or Voluntary Disclosure and Effect on Individual Not Providing Information: The disclosure is voluntary. However, a special camping permit cannot be issued without the information Section 327.7, Part 327, Chapter III, CFR prohibits camping except in areas designated by the District Engineer. The only areas designated for camping are developed public use areas and camping-by-permit-only areas. Violators of Section 327.7 shall be subject to a citation and trial under the provisions of Section 3401, Title 19, USC.
