# 1 Introduction

## 1.1 Overview

The United States Army Corps of Engineers (USACE) Little Rock District is revising the Nimrod Lake Master Plan (MP) and Blue Mountain Lake MP. Each MP guides the management of the government-owned lands around the shoreline of each lake. The MPs affect future management of natural resources and recreational opportunities to ensure the sustainability of both lakes.

The MP is the guidance document that describes how the resources of each lake will be managed in the future and provides the vision of how each lake should look in the future. After the MPs are revised, the Operational Management Plan (OMP) for each lake will be revised to be consistent with the goals identified in the MP.

The current Nimrod Lake and Blue Mountain Lake MPs were developed nearly 50 years ago, and original estimates of future population and land use do not align with current demographics. Therefore, the MP revisions will re-classify the government lands around the lake based on environmental; recreational; socioeconomic considerations; public input; and an evaluation of past, present, and forecasted trends.

USACE Engineer Regulation (ER) and Engineer Pamphlet (EP) 1130-2-550 with Change 7 and Change 5, respectively, dated January 30, 2013, establish guidance for developing MPs and OMPs for USACE Civil Works projects. MPs are required for fee-owned lands, in addition to civil works projects, for which USACE has administrative responsibility for management of natural and manmade resources. The primary goals of a MP are to “prescribe an overall land use management plan, resource objectives, and associated design and management concepts” (EP 1130-2-550). MPs are reviewed every 5 years, and minor changes are made through supplements. A MP that has been excessively supplemented, is out-of-date, or does not serve its intended purpose due to changes in the project should be revised.

USACE will be preparing an Environmental Assessment (EA) to accompany each lake’s revised MP in compliance with the National Environmental Policy Act (NEPA) of 1969 (as amended), the Council on Environmental Quality (CEQ) guidelines (40 Code of Federal Regulations [CFR] Parts 1500-1508), and ER 200-2-2 Procedures for Implementing NEPA. The EAs will evaluate the potential environmental effects of the MP revisions. However, an Environmental Impact Statement (EIS) would be prepared if significant environmental effects are identified during preparation of each EA as a result of the MP revisions.

## 1.2 Purpose and Need for Master Plan

The purpose of the project is to review and revise the Nimrod Lake and Blue Mountain Lake MPs. Both plans strive to balance public use of federal lands and waters with the conservation and protection of natural resources for future generations. Updates of the MPs are needed for the following reasons:

- To ensure accurate land classification and resource protection for future generations.
- To update the plan formats and mapping to modern requirements.
- To better reflect current USACE policies, regulations, budget processes, and business line performance measures.
- Customer uses have remained similar, but trends, recreation equipment (RV size, vessel size, etc.), facility use (amp service, Wi-Fi, etc.), and service demands have shifted since approval of the current 1975 MPs.
- Partners, landowners, and stakeholders are engaged with USACE and seek to increase and sustain benefits provided by the lake.
- To identify issues related to ecosystem stewardship including vegetation and siltation management.

### 1.3 Project Areas

Nimrod Dam is located in Perry County, Arkansas on the Fourche LaFave River. Construction was completed in 1942. Nimrod Lake was authorized by the Flood Control Act of June 28, 1938. The lake is comprised of 25,278 acres of land and water, with approximately 81 miles of boundary line. The lake provides many recreational opportunities and is a key contributor to a large variety of fish and wildlife habitat.

Blue Mountain Dam is located in Yell County, Arkansas on the Petit Jean River. Construction was completed in 1947. Nimrod Lake was authorized by the Flood Control Act of June 28, 1938. The lake is comprised of 17,263 acres of land and water, with approximately 78 miles of boundary line. The lake provides many recreational opportunities and is a key contributor to a large variety of fish and wildlife habitat.

### 1.4 Purpose of this Report

The following report summarizes the public participation process for, and the public comments resulting from, the Nimrod Lake and Blue Mountain Lake MP Revision draft plans release public workshop and comment period.

## 2 Draft Plan Release Process

### 2.1 Overview

In accordance with NEPA and ER 200-2-2, USACE initiated the environmental compliance and review process for the Nimrod Lake and Blue Mountain Lake MP revision projects. EAs have been prepared to identify potential direct, indirect, and cumulative impacts related to implementation of the MPs.

The Nimrod Lake and Blue Mountain Lake revised MPs have been prepared as individual, lake-specific documents, each with its own accompanying EA. While revisions will be documented in lake-specific MPs/EAs, public review periods were held concurrently for both projects. Nimrod Lake and Blue Mountain Lake are close in proximity and likely see public visitation from similar entities. Tribal Nation and resource agency interests also overlap. To streamline

the public involvement process, outreach efforts and public comment opportunities were advertised and occurred simultaneously for both MP revision efforts.

As part of the draft plans release phase of the environmental process, a 32-day comment period was held from May 8 to June 8, 2024, for the public and agencies. A public workshop was held on May 21 to gather comments on the draft revised MPs and the associated draft EAs. The workshop gave the public an opportunity to learn about the alternatives and provide input on the draft MPs and EAs. An agency workshop was held on May 22 and a virtual attendance option was also available.

Workshop attendees were provided a comment card that allowed for comments regarding the draft plans and the environmental reviews. The comment cards included a set of questions for each lake so commentors had the option to respond for either or both. The questions were as follows:

- What alternative best encompasses your vision for the future of the lake?
- What, if any, changes would you like to see to this alternative?
- Additional comments on the MP revision.

USACE published notice of the draft release comment period through several avenues, including: an email blast, a direct mail postcard, press releases, flyers, a notice placed on the Recreation 1 Stop (R1S) website, agency notification letters, announcements on the Nimrod Lake and Blue Mountain Lake Master Plan revision website and the Little Rock District Facebook page. The postcard and email notifications were sent to landowners adjacent to USACE-owned lands around the lake, holders of fishing licenses purchased in Arkansas whose listed zip code is within 7 miles of Nimrod Lake or Blue Mountain Lake, stakeholders, and those who held reservations to camp at Nimrod Lake and Blue Mountain Lake campgrounds within the 2022 recreational season. Postcards were also sent to those for whom only a postal address was available; all others received email notifications. Additionally, flyers were posted on bulletin boards at campgrounds and recreational facilities throughout the lakes and notification letters were sent to potentially interested tribal governments and agencies.

## **2.2 Nimrod Lake and Blue Mountain Lake MP Website**

A website was developed for the MPs revision project. The site included information about Nimrod and Blue Mountain Lakes, the MP and SMP revision process, the revised draft MP, and the draft EAs. Information on the site included the dates and locations of the public workshop, how to submit comments, and who to contact for more information. The website also contained online interactive maps, an online comment form, and the Master Plan revision timeline. There was a total of 694 visits to the Nimrod Lake and Blue Mountain Lake MP website. The website link is listed below:

## **2.3 Public Outreach**

Notification of the draft release comment period was completed via several forms of media as

described further in this section.

### **2.3.1 Notification Database**

USACE maintains a database of stakeholder groups interested in activities around Nimrod Lake and Blue Mountain Lake. In addition, USACE developed a list of adjacent property owners based on the databases maintained by the county assessors of the surrounding counties. USACE also compiled a list of parties who had made campground reservations through the RIS reservation system for camping visits at Nimrod Lake and Blue Mountain Lake during the 2022 camping season. Finally, USACE obtained the database of holders of fishing permits purchased in Arkansas whose listed zip code were within seven miles of Nimrod Lake or Blue Mountain Lake.

### **2.3.2 Public Notification Activities**

Strategies to engage the public to participate in the MP visioning and environmental review processes included (1) making it easy to participate, (2) providing easy-to-understand information that helps people provide informed comments, and (3) ensuring that stakeholders are aware of the planning process and understand how public input will be used.

#### ***2.3.2.1 Direct Mail Notification***

On May 8, 2024, a total of 6,211 postcards were mailed to adjacent property owners, stakeholders, and holders of fishing permits purchased in Arkansas whose listed zip code were within seven miles of Nimrod Lake or Blue Mountain Lake. The distribution of postcard recipients is illustrated in Figure 2-4 by zip code.

The postcard notification included information on the MP revision process, how to provide comments, the comment period closing date, and the project website address. The direct mail postcard is included in Attachment C.

#### ***2.3.2.2 E-mail Notification***

An e-mail blast was sent on May 8, 2024, to approximately 2,959 email addresses. These emails were sent to stakeholders and those listed on the RIS reservation list for whom valid email addresses were available. The information in the email blast was the same as the information on the postcard notification.

#### ***2.3.2.3 Project Website***

A project website was developed for both MP revision projects. The site includes information about Nimrod Lake and Blue Mountain Lake, the MP revision process, interactive maps, a comment form, and information regarding the draft release process. Information on how to submit comments and who to contact for more information regarding the draft release process were included. The project website received a total of 694 hits between the dates of May 8 and June 8, 2024. The website link is listed below:

#### 2.3.2.4 Other Notification Activities

To maximize the media coverage of the outreach efforts relating to the draft release comment period, a media release was sent to local media outlets using the Southwestern Division, Little Rock District, Nimrod Lake and Blue Mountain Lake Media distribution list on May 8, 2024. The Little Rock District Public Affairs office also posted notifications of the draft release comment period and associated pertinent data on their Facebook page. A copy of the press release and Facebook post are located in Attachment C, and copies of the media coverage are located in Attachment G. A draft release notification was also placed on each lake's RIS website during the draft release comment period. A screen shot and verbiage of this notification is available in Attachment C.

#### 2.3.2.5 Website Statistics

Due to the loss of the ability to utilize short URLs, USACE was not able to obtain metrics on the source of the hits which would allow USACE to evaluate the effectiveness of each notification method. Regardless, a total of 694 hits were made on the Nimrod Lake and Blue Mountain Lake MP website during the draft release comment period. A breakdown of the number of views for each page is listed below.

#### 2.3.3 Public Workshop

USACE hosted a public workshop to gather input on the draft revised MPs and the draft EAs. The workshop was scheduled in compliance with NEPA guidelines, and the location was selected to reflect equitable geographic coverage. The meeting location was within the project areas near the lakes. The location was also Americans with Disabilities Act (ADA) compliant. The workshop was held 14 days after the draft documents became available to the public.

A total of 25 people/parties signed in at the workshop. A total of six comment cards were returned at the workshop and an additional 16 comment submittals were received via letters, email, and mailed comment cards during the public comment period. In total, 19 comment submittals from members of the public and four comments from agencies were received by the end of the comment period. Figure 2-1 and Figure 2-2 provides photos from the day of the event. The public workshop meeting summary is as follows:

### 2.3.3.1 Public Workshop Format

The purpose of the public workshop was to present the alternatives for both plans and get feedback on the draft revised MPs and the draft EAs. Two computers were set up during the workshop with links to the online interactive map of the lake and the alternative land classifications to facilitate responses to questions about the lake and the MP revision. Additionally, large, printed maps of Nimrod Lake and Blue Mountain Lake displaying the preferred alternative land classifications were available for review (Figure 2-3).

Written comments were collected at the workshop in the form of the comment cards and were also accepted by mail, fax, and e-mail after the workshop until the close of the comment period.

### 2.3.3.2 Public Workshop Materials


Each workshop attendee was provided a double-sided fact sheet (Attachment D) and a comment card (Attachment D). The fact sheet provided a brief overview and comparison of the alternatives for both plans. The comment card included information on how to comment and allowed attendees to either submit written comments at the workshop or to mail them in after the workshop. The comment card was designed as a self-mailer so that individuals could easily mail comments to USACE if they needed more time to develop their comments after attending the public workshop.

## 2.4 Comments Received

The public draft release comment period was held from May 8 to June 8, 2024, which provided a 32-day comment period. All persons interested in providing feedback on the draft plans were provided opportunities to submit written comments at the workshop as well as via email, fax, or mail. The comment cards distributed at the public workshop were designed to facilitate return of written comments either at the public workshop or via mail later during the public comment period. Email comments could be sent to a project specific email address, which was included

on the Nimrod Lake and Blue Mountain Lake MP revision website as well as on all of the notice materials distributed. Many workshop participants took multiple comment cards to distribute to friends and family who were not able to attend the workshop in person.

In total, 19 comments (letters, emails, comment cards) from members of the public were received. 13 individuals provided comments pertaining to the Blue Mountain Lake Master Plan revision, and seven individuals provided comments pertaining to the Nimrod Lake Master Plan revision. Four comment submittals from agencies were received by the end of the comment period and pertained to both revisions. Copies of all the public comments submitted during the comment period are included in Attachment E. Copies of agency submittals are included in Attachment F.

## **3 Summary of Draft Release Comments**

### **3.1 Introduction**

USACE accepted comments on the Nimrod Lake and Blue Mountain Lake MPs throughout the entire draft release comment period from May 8 through June 8, 2024. Community groups, agencies, members of the public, and other interested parties submitted 23 letters, e-mails, and comment cards during this period. The summary tables (Table 3-1 and Table 3-2) provide a tally of the topics discussed in the comments.

It should be noted that the combined numbers of comments listed in the following subsections and the summary table will be greater than the total number of comment submissions because most individuals discussed multiple topics in their submission. Topics covered in the comments included general comments about the plan and the environmental review as well as answers to the following questions:

- What alternative best encompasses your vision for the future of Nimrod Lake/Blue Mountain Lake?
- What, if any, changes would you like to see to this alternative?
- Additional comments on the Nimrod Lake/Blue Mountain Lake Master Plan Revision.

This section contains a summary of comments received during the comment period. The actual comments may be found in Attachments E and F.

### **3.2 Summary of Comments**

Table 3-1 and Table 3-2 provide a summary of the comments received during the comment period. While these tables do not include every comment received, they provide a general summary of the topics most frequently submitted during the comment period. The number of times a comment was raised by a different respondent is noted in parenthesis. A more detailed overview of comments follows in Sections 3.2.1 through 3.2.4. Several comments were not related to the plan or the environmental review. It is important to note that concerns regarding lake elevations are not within the scope of the Master Plan but instead are within the intent of the Water Control Plan. State fishing regulations are also not within the scope of the Master Plan. This draft release report will not address water/lake levels or state fishing regulations, nor will the MP or accompanying EA.

### **3.2.1 Alternative Preference Comments**

#### ***3.2.1.1 Nimrod Lake***

The most common response to Question 1 was that people preferred Alternative 2 as the alternative that best encompasses their vision for the future of Nimrod Lake (Table 3-1). Two commentors chose Alternative 1. One commentor said they would prefer an alternative with no drawdowns and one simply stated to open County Line Park.

#### ***3.2.1.2 Blue Mountain Lake***

The most frequent responses to Question 1 were related to recreation area maintenance and improvements and were not any of the three alternatives (Table 3-2). Alternative 1 and Alternative 2 each received one comment as the chosen alternative. Several other comments were made one time and covered various topics.

### **3.2.2 Comments Related to Changes to Preferred Alternative**

#### ***3.2.2.1 Nimrod Lake***

The top responses to what changes commentors would like to see regarding their preferred alternative were the re-opening of County Line Park and reopening access to trails and roads that have been blocked (Table 3-1). Two respondents chose each of these changes. Several comments were mentioned only one time and included changes related to fishing or boating regulations, natural resource management, and changes specific to individual recreation areas.

#### ***3.2.2.2 Blue Mountain Lake***

The top responses to what changes commentors would like to see regarding their preferred alternative were the upgrading of Ashley Creek Park facilities with five comments and the dredging of Ashley Creek and other ramps with four comments (Figure 3-2). General recreation area maintenance and improvements along with a 10” crappie restriction received two comments each. Several individual comments were submitted regarding various recreation areas and activities along with natural resource management items.

### **3.2.3 Additional Comments**

This question allowed for various comments other than those derived from Questions 1 and 2 but most comments in these cases were closely related.

#### ***3.2.3.1 Nimrod Lake***

The additional comment responses submitted for Nimrod Lake were similar to the changes members of the public wanted made to the alternatives. The comment that was made twice was again desiring the re-opening of County Line Park (Table 3-1). Several comments were made only one time and were related to allowing access to closed roads and trails, wildlife and fishery habitat improvement, and other specific items.

#### ***3.2.3.2 Blue Mountain Lake***

The additional comment responses for Blue Mountain Lake were similar to the changes members of the public wanted made to the alternatives. Making improvements to Ashley Creek Park was

the most popular comment and was listed four times (Table 3-2). Other comments were made only one time. The ones that hadn't been commented on in other questions were related to safety concerns due to recreation area disrepair, regulating the number of fishing tournaments, and Lick Creek Ramp improvement.

### **3.2.4 Agency and Tribal Government Comments**

Four agencies submitted comments during the draft release comment period. No comments received expressed a negative or positive preference for any alternative. The official agency letters and emails are included in Attachment F. Agencies that commented during the comment period included:

- Arkansas Department of Health
- Arkansas Game and Fish Commission
- Cherokee Nation
- Choctaw Nation

Agency and tribal government comments are summarized in this section. The full text of the agency comments is available in Attachment F. Comments not covered in earlier sections or regarding specific areas of the lake include:

- Arkansas Department of Health informed us that the Plainview Water Department, Danville Waterworks, and Blue Mountain Lake are within Source Water Assessment Areas and asked to be notified if any construction takes place in these areas.
- Arkansas Game and Fish Commission stated that it had no further comments.
- The Cherokee Nation found no instances where our MP projects intersect or adjoin their cultural, historic, or pre-historic resources in their records. They ask that we halt all activities if cultural items are discovered and that we check with other historic preservation offices as well.
- The Choctaw Nation informed us the areas involved are outside of their historic interest and defers to the other tribes contacted.

## **4 Next Steps: Master Plan Revision Process**

The purpose of the Nimrod Lake and Blue Mountain Lake MP Revision draft plan release workshop and comment period was to provide an opportunity for agencies and the public to learn about the draft alternatives and provide input on the draft MPs and EAs to help guide future land use and management at Nimrod Lake and Blue Mountain Lake.

USACE will consider the comments and issues identified during the draft release comment period as the final MPs and EAs are developed. The final MPs and EAs will be made available to the public. It is anticipated that this will occur in Fall 2024.

Individual responses to comments provided during the draft release comment periods are not developed in the preparation of an EA. Where consistent with the purpose of an MP and where

possible under the planning mechanisms utilized during a MP revision, USACE will incorporate the feedback and suggestions provided through the comments.



The Nation maintains databases and records of cultural, historic, and pre-historic resources in this area. Our Historic Preservation Office (Office) reviewed this project, cross referenced the project's legal description against our information, and found no instances where this project intersects or adjoins such resources. Thus, the Nation does not foresee this project imparting impacts to Cherokee cultural resources at this time.

However, the Nation requests that the United States Army Corps of Engineers (USACE) halt all project activities immediately and re-contact our Office for further consultation if items of cultural significance are discovered during the course of this project. Additionally, the Nation requests that USACE conduct appropriate inquiries with other pertinent Historic Preservation Offices regarding historic and prehistoric resources not included in the Nation's databases or records.
