d. <u>Lessee Not to Participate in Certain Federal Cost Sharing for Soil Conservation</u> <u>Practices</u>. Certain soil conservation practices required by the land use management regulations are subject to rental abatement. By acceptance of this abatement, the lessee agrees that he will not accept any Federal or State cost-sharing payments or subsidies for the same soil conservation practices. The lessee may, however, elect to receive USDA conservation benefits for such conservation practices instead of a rental abatement.

That the Secretary, by authority of Title 10, United States Code, Section 2667, and for the consideration set forth herein, hereby leases to the Lessee the property hereinafter identified as **Lease Plot No. ##-##, Any County, Arkansas**, containing ## acres, more or less, as outlined on the attached Lease Plot Photo Map, attached hereto and made a part hereof, hereinafter referred to as the premises, for **HAYLAND/CROPLAND** purposes, and in accordance with the Land Use Regulations identified in Exhibit "A", which is attached hereto and made a part hereof.

THIS LEASE is granted subject to the following conditions:

#### 1. TERM

Said premises are hereby leased for a term of **Five (5) years**, beginning **January 1, 2023**, and ending **December 31, 2027**, but revocable at will by the Secretary.

## 2. CONSIDERATION

a. The Lessee shall pay rental in advance to the United States in the amount of ######## and No/100 Dollars (\$#.##) per annum, payable annually in advance, to the order of the FAO, U. S. Army, Little Rock District, and mailed to the U.S. Army Corps of Engineers Finance Center, ATTN: CEFC-AD-C, 5720 Integrity Drive, Millington, Tennessee 38054-5005.

**b.** All rent and other payments due under the terms of this lease must be paid on or before the date they are due in order to avoid the mandatory sanctions imposed by the Debt Collection Act of 1982, (31 U.S.C. Section 3717). This statute requires the imposition of an interest charge for the late payment of debts owed to the United States; an administrative charge to cover the costs of processing and handling delinquent debts; and the assessment of an additional penalty charge on any portion of a debt that is more than 90 days past due. The provisions of the statute will be implemented as follows:

(1) The United States will impose an interest charge, the amount to be determined by law or regulation, on late payment of rent. Interest will accrue from the later of the due date or the date notification of the amount due is mailed to the Lessee. If, however, this lease is revoked, the Lessee shall vacate the premises, remove said property and restore the premises to the aforesaid condition within such time as the said officer may designate or as other- wise specified by the provisions of the condition on **RENTAL ADJUSTMENT.** In either event, if the Lessee shall fail or neglect to remove said property and restore the premises, then, at the option of said officer, the property shall either become the property of the United States without compensation therefor, or the said officer may cause the property to be removed and no claim for damages against the United States

or its officers or agents shall be created by or made on account of such removal and restoration work. The Lessee shall also pay the United States on demand any sum which may be expended by the United States after the expiration, revocation or termination of this lease in restoring the premises.

# 14. NON-DISCRIMINATION

The Lessee shall not discriminate against any person or persons or exclude them from participation in the Lessee's operations, programs or activities conducted on the leased premises, because of race, color, religion, sex, age, handicap or national origin.

# **15. SUBJECT TO EASEMENTS**

This lease is subject to all existing easements, or those subsequently granted as well as established access routes for roadways and utilities located, or to be located, on the premises, provided that the proposed grant of any new easement or route will be coordinated with the Lessee, and easements will not be granted which will, in the opinion of the Chief, Real Estate Division, interfere with the use of the premises by the Lessee.

#### 16. SUBJECT TO MINERAL INTERESTS

This lease is subject to all outstanding mineral interests. As to federally-owned mineral interests, it is understood that they may be included in present or future mineral leases issued by the Bureau of Land Management (BLM) which has responsibility for mineral development of Federal lands. The Secretary will provide lease stipulations to BLM for inclusion in said mineral leases that are designed to protect the premises from activities that would interfere with the Lessees operations or would be contrary to local law.

#### **17. TERMINATION**

This lease may be terminated by the Lessee at any time by giving at least sixty (60) days notice thereof, in writing, to the Chief, Real Estate Division. In the case of such termination, no refund by the United States of any rental previously paid shall be made and payment in full of all rent becoming due during the period of notice will be required. In the event the effective date of termination occurs after the start of the grazing, planting or harvesting season as specified in the Land Use Regulations, any rent due for the balance of the annual term, or the rental due for the remaining term if the lease is for less than one year, shall be due and payable on or before the date of such termination.

#### **18. PROHIBITED USES**

**a.** Certain soil conservation practices may be required by the land use regulations which are identified as rental offsets. By acceptance of such offsets, the Lessee agrees that he will not accept any Federal or State cost-sharing payments or subsidies for the same soil conservation practices.

**b.** The Lessee shall not construct or place any structure, improvement or advertising sign or allow or permit such construction or placement without prior written approval of the Chief, Real Estate Division.

## **19. PROTECTION OF NATURAL RESOURCES**

The Lessee shall use the premises in accordance with the attached Land Use Regulations and shall at all times: (a) maintain the premises in good condition and free from weeds, brush, washes, gullies and other erosion which is detrimental to the value of the premises for agricultural purposes; (b) cut no timber, conduct no mining operations, remove no sand, gravel or kindred substances from the premises; (c) commit no waste of any kind nor in any manner substantially change the contour or condition of the premises except changes required to

accomplish soil and water conservation measures as may be authorized by said officer.

## **20. DISPUTES**

**a.** Except as provided in the Contract Disputes Act of 1978 (41 U.S.C. 7101-7109) (the Act), all disputes arising under or relating to this lease shall be resolved under this clause and the provisions of the Act.

**b.** "Claim," as used in this clause, means a written demand or written assertion by the Lessee seeking, as a matter of right, the payment of money in a sum certain, the adjustment of interpretation of lease terms, or other relief arising under or relating to this lease. A claim arising under this lease, unlike a claim relating to this lease, is a claim that can be resolved under a lease clause that provides for the relief sought by the Lessee. However, a written demand or written assertion by the Lessee seeking the payment of money exceeding \$100,000 is not a claim under the Act until certified as required by subparagraph c.(2) below. The routine request for rental payment that is not in dispute is not a claim under the Act. The request may be converted to a claim under the Act, by this clause, if it is disputed either as to liability or amount or is not acted upon in a reasonable time.

**c.** (1) A claim by the Lessee shall be made in writing and submitted to the Chief, Real Estate Division for a written decision. A claim by the Government against the Lessee shall be subject to a written decision by the Chief, Real Estate Division.

(2) For Lessee claims exceeding \$100,000, the Lessee shall submit with the claim a certification that:

(i) The claim is made in good faith;

(ii) Supporting data are accurate and complete to the best of the Lessee's knowledge and belief; and

(iii) The amount requested accurately reflects the lease adjustment for which the Lessee believes the Government is liable.

(3) If the Lessee is an individual, the certificate shall be executed by that individual. If the Lessee is not an individual, the certification shall be executed by:

(i) A senior company official in charge at the Lessee's location involved; or

(ii) An officer or general partner of the Lessee having overall responsibility of the conduct of the Lessee's affairs.

**d.** For Lessee claims of \$100,000 or less, the Chief, Real Estate Division must, if requested in writing by the Lessee, render a decision within 60 days of the request. For Lessee-certified claims over \$100,000, the Chief, Real Estate Division must, within 60 days, decide the claim or notify the Lessee of the date by which the decision will be made.

**e.** The Chief, Real Estate Division's decision shall be final unless the Lessee appeals or files a suit as provided in the Act.

**f.** At the time a claim by the Lessee is submitted to the Chief, Real Estate Division or a claim by the Government is presented to the Lessee, the parties, by mutual consent, may agree to use alternative means of dispute resolution. When using alternate dispute resolution procedures, any claim, regardless of amount, shall be accompanied by the certification described in paragraph c.(2) of this clause, and executed in accordance with paragraph c.(3) of this clause.

**g.** The Government shall pay interest on the amount found due and unpaid by the Government from (1) the date the Chief, Real Estate Division received the claim (properly certified if required), or (2) the date payment otherwise would be due, if that date is later, until the date of payment. Simple interest on claims shall be paid at the rate, fixed by the Secretary of the Treasury, as provided in the Act, which is applicable to the period during which the Chief, Real Estate Division receives the claim and then at the rate applicable for each 6-month period as fixed by the Treasury Secretary during the pendency of the claim. Rental amounts due to the Government by the Lessee will have interest and penalties as set out in Condition No. 2, "CONSIDERATION."

**h.** The Lessee shall proceed diligently with performance of the lease, pending final resolution of any request for relief, claim, appeal, or action arising under the lease, and comply with any decision of the Chief, Real Estate Division

## 21. ENVIRONMENTAL PROTECTION

**a.** Within the limits of their respective legal powers, the parties to this lease shall protect the premises against pollution of its air, ground and water. The Lessee shall comply with any laws, regulations, conditions or instructions affecting the activity hereby authorized if and when issued by the Environmental Protection Agency, or any Federal, state, interstate or local governmental agency having jurisdiction to abate or prevent pollution. The disposal of any toxic or hazardous materials within the premises is specifically prohibited. Such regulations, conditions or instructions in effect or prescribed by the said Environmental Protection Agency, or any Federal, state, inter- state or local governmental agency are hereby made a condition of this lease. The Lessee shall not discharge waste or effluent from the premises in such a manner that the discharge will contaminate streams or other bodies of water or otherwise become a public nuisance.

**b.** The Lessee will use all reasonable means available to protect the environment and natural resources, and where damage nonetheless occurs arising from activities of the Lessee, the Lessee shall be liable to restore the damaged resources.

**c.** The Lessee must obtain approval in writing from said officer before any pesticides or herbicides are applied to the premises.

#### 22. HISTORIC PRESERVATION

The Lessee shall not remove or disturb, or cause or permit to be removed or disturbed, any historical, archeological, architectural or other cultural artifacts, relics, remains or objects of antiquity. In the event such items are discovered on the premises, the Lessee shall immediately notify said officer and protect the site and the material from further disturbance until said officer gives clearance to proceed.

#### 23. SOIL AND WATER CONSERVATION

The Lessee shall maintain, in a manner satisfactory to said officer, all soil and water conservation structures that may be in existence upon the premises at the beginning of or that may be constructed by the Lessee during the term of this lease, and the Lessee shall take appropriate measures to prevent or control soil erosion within the premises. Any soil erosion occurring outside the premises resulting from the activities of the Lessee shall be corrected by the Lessee as directed in writing by the Chief, Real Estate Division.

## 24. TAXES

Any and all taxes imposed by the state or its political subdivisions upon the property or interest of the Lessee in the premises shall be promptly paid by the Lessee. If and to the extent that the property owned by the Government is later made taxable by State or local governments under an Act of Congress, the lease shall be renegotiated.

## 25. COVENANT AGAINST CONTINGENT FEES

The Lessee warrants that no person or selling agency has been employed or retained to solicit or secure this lease upon an agreement or understanding for a commission, percentage, brokerage or contingent fees, except bona fide employees or established commercial or selling agencies maintained by the Lessee for the purpose of securing business. For breach or violation of this warranty, the United States shall have the right to annul this lease without liability or, in its discretion, to require the Lessee to pay, in addition to the lease rental or consideration, the full amount of such commission, percentage, brokerage or contingent fee.

## 26. OFFICIALS NOT TO BENEFIT

No member of or delegate to congress or resident commissioner shall be admitted to any share or part of this lease or to any benefits to arise therefrom. However, nothing herein contained shall be construed to extend to any incorporated company if this lease is for the general benefit of such corporation or company.

## 27. SEVERAL LESSEES

If more than one Lessee is named in this lease, the obligations of said Lessees herein named shall be joint and several obligations.

#### 28. MODIFICATIONS

This lease contains the entire agreement between the parties hereto, and no modifications of this agreement, or waiver, or consent hereunder shall be valid unless the same be in writing, signed by the parties to be bound or by a duly authorized representative and this provision shall apply to this condition as well as other conditions of this lease.

#### **29. DISCLAIMER**

This lease is effective only insofar as the rights of the United States in the premises are concerned. The Lessee shall obtain any permit or license which may be required by Federal, state or local statute in connection with the use of the premises. It is understood that the granting of this lease does not preclude the necessity of obtaining a Department of the Army permit for activities which involve the discharge of dredge or fill material or the placement of fixed structures in the waters of the United States, pursuant to the provisions of Section 10 of the Rivers and Harbors Act of 3 March 1899 (33 USC 403), and Section 404 of the Clean Waters Act (33 USC 1344).

**30.** That the Lessee will cooperate in programs for the management and improvement of fish and wildlife and in furtherance thereof the leased premises will be subject to free public use for fishing and hunting. Hunting and fishing are permitted in accordance with all applicable Federal, state, and local laws for the protection of fish and game, except in prohibited areas designated by the said officer.

## 31. Executive Order 13658", to read:

"(a) Any reference in this section to "prime contractor" or "contractor" shall mean the Lessee and any reference to "contract" shall refer to the Lease. The parties expressly stipulate this contract is subject to Executive Order 13658, the regulations issued by the Secretary of Labor in 29 CFR part 1 0 pursuant to the Executive Order, and the following provisions.

## (b) Minimum Wages.

(1) Each worker (as defined in 29 CFR 10.2) engaged in the performance of this contract by the prime contractor or any subcontractor, regardless of any contractual relationship which may be alleged to exist between the contractor and worker, shall be paid not less than the applicable minimum wage under Executive Order 13658.

(2) The minimum wage required to be paid to each worker performing work on or in connection with this contract between January 1, 2015 and December 31, 2015 shall be \$10.10 per hour. The minimum wage shall be adjusted each time the Secretary of Labor's annual determination of the applicable minimum wage under section 2(a)(ii) of Executive Order 13658 results in a higher minimum wage. Adjustments to the Executive Order minimum wage under section 2(a)(ii) of Executive Order 13658 will be effective for all workers subject to the Executive Order beginning January 1 of the following year. If appropriate, the contracting officer, or other agency official overseeing this contract shall ensure the contractor is compensated only for the increase in labor costs resulting from the annual inflation increases in the Executive Order 13658 minimum wage beginning on January 1, 2016. The Secretary of Labor will publish annual determinations in the Federal Register no later than 90 days before such new wage is to take effect. The Secretary will also publish the applicable minimum wage on www.wdol.gov (or any successor Web site). The applicable published minimum wage is incorporated by reference into this contract.

(3) The contractor shall pay unconditionally to each worker all wages due free and clear and without subsequent deduction (except as otherwise provided by 29 CFR 10.23), rebate, or kickback on any account. Such payments shall be made no later than one pay period following the end of the regular pay period in which such wages were earned or accrued. A pay period under this Executive Order may not be of any duration longer than semi-monthly.

(4) The prime contractor and any upper-tier subcontractor shall be responsible for the compliance by any subcontractor or lower-tier subcontractor with the Executive Order minimum wage requirements. In the event of any violation of the minimum wage obligation of this clause, the contractor and any subcontractor(s) responsible therefore shall be liable for the unpaid wages.

(5) If the commensurate wage rate paid to a worker on a covered contract whose wages are calculated pursuant to a special certificate issued under 29 U.S.C. 214(c), whether hourly or piece rate, is less than the Executive Order minimum wage, the contractor must pay the Executive Order minimum wage rate to achieve compliance with the Order. If the commensurate wage due under the certificate is greater than the Executive Order minimum wage, the contractor must pay the 14(c) worker the greater commensurate wage.

(c) Withholding. The agency head shall upon its own action or upon written request of an authorized representative of the Department of Labor withhold or cause to be withheld from the prime contractor under this or any other Federal contract with the same prime contractor, so much of the accrued payments or advances as may be considered necessary to pay workers the full amount of wages required by Executive Order 13658.

(d) Contract Suspension/Contract Termination/Contractor Debarment. In the event of a failure to pay any worker all or part of the wages due under Executive Order 13658 or 29 CFR part 10, or a failure to comply with any other term or condition of Executive Order 13658 or 29 CFR part 10, the contracting agency may on its own action or after authorization or by direction of the Department of Labor and written notification to the contractor, take action to cause suspension of any further payment, advance or guarantee of funds until such violations have ceased. Additionally, any failure to comply with the

requirements of this clause may be grounds for termination of the right to proceed with the contract work. In such event, the Government may enter into other contracts or arrangements for completion of the work, charging the contractor in default with any additional cost. A breach of the contract clause may be grounds for debarment as a contractor and subcontractor as provided in 29 CFR 1 0.52.

(e) The contractor may not discharge any part of its minimum wage obligation under Executive Order 13658 by furnishing fringe benefits or, with respect to workers whose wages are governed by the Service Contract Act, the cash equivalent thereof.

(f) Nothing herein shall relieve the contractor of any other obligation under Federal, State or local law, or under contract, for the payment of a higher wage to any worker, nor shall a lower prevailing wage under any such Federal, State, or local law, or under contract, entitle a contractor to pay less than \$10.10 (or the minimum wage as established each January thereafter) to any worker.

(g) Payroll Records.

(1) The contractor shall make and maintain for three years records containing the information specified in paragraphs (g)(1) (i) through (vi) of this section for each worker and shall make the records available for inspection and transcription by authorized representatives of the Wage and Hour Division of the U.S. Department of Labor:

- (i) Name, address, and social security number.
- (ii) The worker's occupation(s) or classification(s).
- (iii) The rate or rates of wages paid.
- (iv) The number of daily and weekly hours worked by each worker.
- (v) Any deductions made; and
- (vi) Total wages paid.

(2) The contractor shall also make available a copy of the contract, as applicable, for inspection or transcription by authorized representatives of the Wage and Hour Division.

(3) Failure to make and maintain or to make available such records for inspection and transcription shall be a violation of 29 CFR part 10 and this contract, and in the case of failure to produce such records, the contracting officer, upon direction of an authorized representative of the Department of Labor, or under its own action, shall take such action as may be necessary to cause suspension of any further payment or advance of funds until such time as the violations are discontinued.

(4) The contractor shall permit authorized representatives of the Wage and Hour Division to conduct investigations, including interviewing workers at the worksite during normal working hours.

(5) Nothing in this clause limits or otherwise modifies the contractor's payroll and recordkeeping obligations, if any, under the Davis-Bacon Act, as amended, and its implementing regulations; the Service Contract Act, as amended, and its implementing regulations; the Fair Labor Standards Act, as amended, and its implementing regulations; or any other applicable law.

(h) The contractor (as defined in 29 CFR 1 0.2) shall insert this clause in all of its covered subcontracts and shall require its subcontractors to include this clause in any covered lower-tier subcontracts. The prime contractor and any upper-tier subcontractor shall be responsible for the compliance by any subcontractor or lower-tier subcontractor with this contract clause.

(i) Certification of Eligibility.

(1) By entering into this contract, the contractor (and officials thereof) certifies that neither it (nor he or she) nor any person or firm who has an interest in the contractor's firm is a person or firm ineligible to be awarded Government contracts by virtue of the sanctions imposed pursuant to section 5 of the Service Contract Act, section 3(a) of the Davis-Bacon Act, or 29 CFR 5.12(a)(1).

(2) No part of this contract shall be subcontracted to any person or firm whose name appears on the list of persons or firms ineligible to receive Federal contracts.

(3) The penalty for making false statements is prescribed in the U.S. Criminal Code, 18 U.S.C. 1001.

(j) Tipped employees. In paying wages to a tipped employee as defined in section 3(t) of the Fair Labor Standards Act, 29 U.S.C. 203(t), the contractor may take a partial credit against the wage payment obligation (tip credit) to the extent permitted under section 3(a) of Executive Order 13658. In order to take such a tip credit, the employee must receive an amount of tips at least equal to the amount of the credit taken; where the tipped employee does not receive sufficient tips to equal the amount of the tip credit the contractor must increase the cash wage paid for the workweek so that the amount of cash wage paid and the tips received by the employee equal the applicable minimum wage under Executive Order 13658. To utilize this proviso:

(1) The employer must inform the tipped employee in advance of the use of the tip credit;

(2) The employer must inform the tipped employee of the amount of cash wage that will be paid and the additional amount by which the employee's wages will be considered increased on account of the tip credit;

(3) The employees must be allowed to retain all tips (individually or through a pooling arrangement and regardless of whether the employer elects to take a credit for tips received); and

(4) The employer must be able to show by records that the tipped employee receives at least the applicable Executive Order minimum wage through the combination of direct wages and tip credit.

(k) Antiretaliation. It shall be unlawful for any person to discharge or in any other manner discriminate against any worker because such worker has filed any complaint or instituted or caused to be instituted any proceeding under or related to Executive Order 13658 or 29 CFR part 10, or has testified or is about to testify in any such proceeding.

(1) Disputes concerning labor standards. Disputes related to the application of Executive Order 13658 to this contract shall not be subject to the general disputes clause of the contract. Such disputes shall be resolved in accordance with the procedures of the Department of Labor set forth in 29 CFR part 10. Disputes within the meaning of this contract clause include disputes between the contractor (or any of its subcontractors) and the contracting agency, the U.S. Department of Labor, or the workers or their representatives.

(m) Notice. The contractor must notify all workers performing work on or in connection with a covered contract of the applicable minimum wage rate under the Executive Order. With respect to service employees on contracts covered by the Service Contract Act and laborers and mechanics on contracts covered by the Davis-Bacon Act, the contractor may meet this requirement by posting, in a prominent and accessible place at the worksite, the applicable wage determination under those statutes. With respect to workers performing work on or in connection with a covered contract whose wages are governed by the FLSA, the contractor must post a notice provided by the Department of Labor in a prominent and accessible place at the worksite so it may be readily seen by workers. Contractors that customarily post notices to workers electronically may post the notice electronically provided such electronic posting is displayed prominently on any Web site that is maintained by the contractor, whether external or internal, and customarily used for notices to workers about terms and conditions of employment.

(n) If a duly authorized representative of the United States discovers or determines, whether before or subsequent to executing this contract, that an erroneous determination regarding the applicability of Executive Order 13658 was made, contractor, to the extent permitted by law, agrees to indemnify and hold harmless the United States, its officers, agents, and employees, for and from any and all liabilities, losses, claims, expenses, suits, fines, penalties, judgments, demands or actions, costs, fees, and damages directly or indirectly arising out of, caused by, related to, resulting from or in any way predicated upon, in whole or in part, the erroneous Executive Order 13658 determination. This includes contractor releasing any claim or entitlement it would otherwise have to an equitable adjustment to the contract and indemnifying and holding harmless the United States from the claims of subcontractors and contractor

employees.

THIS LEASE is not subject to Title 10, United States Code, Section 2662, as amended.

# LAND USE REGULATIONS MCCLELLAN-KERR ARKANSAS RIVER NAVIGATION PROJECT PINE BLUFF SITE OFFICE POOLS 0-6

The overall goal of this leasing program is to develop an environment beneficial to the species of wildlife in the area while making certain lands available for the interim use of agriculture and grazing. A properly managed agricultural-grazing operation is one of the tools used for wildlife management. To obtain this goal, certain practices in land management must be followed by the lessees.

## **GENERAL CONDITIONS**

1. The lessee shall conduct all operations in accordance with the land use practices set forth herein in a timely manner at no expense to the Government, unless otherwise provided.

2. The lessee may be directed to perform services in lieu of all or a portion of the cash rental; however, that option is the Real Estate Contracting Officer's and not the lessee's.

3. All operations shall be conducted with extreme care to avoid the destruction or disturbance of reference posts, boundary or survey monument markers or benchmarks.

4. Fencing to meet the lessee's requirements and needed to operate the leased premises consistent with these land use regulations is the responsibility of the lessee. <u>Any</u> new cattle guards, fence construction, or fence replacement must be approved in writing by the Pine Bluff Site Office Manager. It is the responsibility of the lessee to remove interior fences upon termination or expiration of the lease. Current lessee will be responsible in removing all preexisting and newly established interior fences from the lease when the lease becomes terminated. All fencing material shall be removed from government property in a safe and legal manner. Repair of existing fence may be performed as necessary. Fence posts will not be cut from Government property. Fencing will not be attached to trees in any manner.

5. A 75-foot wide un-mowed and unplowed native vegetation <u>buffer</u> strip will be maintained adjacent to both banks of the Arkansas River and the major tributaries to the Arkansas River for erosion control and wildlife cover. A 50-foot wide un-mowed and unplowed native vegetation <u>buffer</u> strip will be maintained adjacent to both banks of all intermittent streams, sloughs, ditches, lakes, and ponds for erosion control and wildlife cover. This buffer strip may not be used as a turnrow or for storage of hay or equipment. The buffer strips will be maintained at all times. In the event of a cave-in or wash-out, the lessee will allow additional land to revert to native vegetation to maintain the buffer strip.

Exhibit "A" Page 1 of 11 6. Grazing will be restricted to horses and cattle only.

7. Proper grazing use for wildlife management is to remove fifty percent or less of the current year's vegetative growth. To maintain ground cover for soil protection and wildlife, animal units have been established on all lease plots where grazing is allowed. The lessee has primary responsibility to prevent overgrazing irrespective of the number of animal units authorized by the lease. Failure to prevent overgrazing will be grounds for lease revocation. During extreme conditions, the Real Estate Contracting Officer's or authorized representative may direct a decrease in the grazing period and/or animal units as necessary. Failure to remove cattle as directed by the Real Estate Contracting Officer's or authorized representative will be grounds for revocation of the lease. If grazing periods and/or animal units are increased or decreased, the lessee will be notified in writing and an increase or decrease in rental will be determined by dividing that portion of the annual rental applicable to lands made available for cattle grazing by the number of authorized animal-unit months (number of animal units multiplied by 12). The determination of rental applicable to lands made available for cattle grazing will be made by the Real Estate Contracting Officer's.

8. The number of animal units to be grazed on the lease plot shall be limited to the number shown on the grazing lease. Animal units are defined as follows:

Horse or pony	
Bull	
Cow	1 Animal Unit
Cow with un-weaned calf	1 Animal Unit
Weaned calf to yearling (400-700 lbs.)	1/2 Animal Unit
Steer or Heifer 1-2 years (over 700 lbs.)	1 Animal Unit

Grazing in excess of authorized animal units will not be tolerated. Violations could result in termination of lease. If lease is terminated and animals are still found on Government property, owner may be issued a citation, per animal, per day, and/or impoundment of the animals in accordance with Code of Federal Regulations, Title 36, Chapter III, Part 327.

Lessees can therefore be required to participate in rental offset for fencing, as authorized by the Work Items Credit Schedule (Land Use Regulations, Attachment 1) in order to prevent overgrazing and/or exceeding authorized animal units.

9. <u>No burning</u> will be allowed without prior written approval from the Site Manager, Pine Bluff Site Office, and the lessee shall protect the lands from wildfire.

10. <u>All pesticides</u>, restricted and non-restricted, must be applied in accordance with label directions. Lessees must possess up-to-date licensing/certification from the Arkansas State Plant

Board prior to applying any restricted use pesticides. Actual quantities will be reported annually to the Real Estate Contracting Officer's on Form No. SWL 343. Forms will be furnished by the Real Estate Contracting Officer's. Improper transportation, use or disposal of any pesticides can be immediate grounds for lease termination.

11. The application of lime and fertilizers must be applied in accordance with recommendations from soil test results. These soil tests can be obtained through the local County Extension Agents Office. Lessees will report actual quantities of lime and fertilizers applied (regardless of whether application is directed by the Real Estate Contracting Officer's to the Real Estate Contracting Officer's annually on Form No. SWL 343. Forms will be furnished by the Real Estate Contracting Officer's.

12. Application of animal or human waste as fertilizer is prohibited. This includes surface or ground injection methods.

13. The Real Estate Contracting Officer's, or his/her authorized representative, shall be allowed to cross the lessee's property, as necessary, to inspect the government property.

14. Tall Fescue cannot be planted on government property. A high percentage of Tall Fescue is believed to be infected with an endophyte fungus that is toxic to both domestic livestock and wildlife. (Case-by-case exceptions will be considered for "DL" (Diversion Levee) lands only.)

Lessee's can therefore be required to participate in rental offset for boundary fencing on certain lease plots, as authorized by the Work Items Credit Schedule (Land Use Regulations, Attachment 1) in order to prevent trespass, overgrazing and excess animal units. Grazing in excess of authorized animal units will not be tolerated. Violations could result in termination of the lease. If the lease is terminated and animals are still found on Government property, the owner may be issued a citation, per animal, per day and/or impoundment of the animals in accordance with Code of Federal Regulations, Title 36, Chapter III, Part 327.

## SPECIAL CONDITIONS

1. <u>PHOTO MAP SYMBOL - "C", CULTIVATION</u>. Lands marked with the symbol "C" on the photo map may be cultivated or utilized for hay production. Livestock grazing is prohibited.

a. The application of lime and fertilizers must be in the quantities and of the analysis indicated by soil tests results which can be obtained upon request through the local County Extension Agents Office.

b. Following a cropping system, a cover crop such as wheat, oats, ryegrass, vetch, or crimson clover may be planted at the option and expense of the lessee. If a cover crop is not planted, the stubble left after harvest must be left to remain over the winter. The stubble may not be cut, tilled, or burned prior to 1 March of the year following the harvest.

c. If rice is planted, the following conditions will apply:

- (1) Rice may only be planted two consecutive years; then an alternate crop must be substituted.
- (2) No food strips will be required in rice fields.
- (3) Buffer and **c**over strips will be maintained as specified under General Conditions No. 5 and Special Condition No. 6.
- (4) Stubble will be rolled or cut for hay, and the levees will be left in place until after the waterfowl season.

d. Should "C" lands be utilized as haylands, the special conditions pertaining to haylands apply.

e. "C" lands can be utilized as orchard land, must be planted in Sweet Pecan (*Carya illinoinensis*) or Black Walnut (*Juglans nigra*). If needed to maintain good seedling growth, lessee is allowed to control weeds and brush by mowing during the period <u>1 March through 1</u> <u>September</u> each year.

f. No disking or tilling of soil shall be administered within three (3') feet from the toe of a levee. However, the three (3') foot buffer strip must be mowed to control woody vegetation. The special conditions pertaining to haylands apply.

2. <u>PHOTO MAP SYMBOL - "HL", HAYLANDS</u>. Lands marked with the symbol "HL" on photo map may be used for hay production only. <u>Livestock grazing is prohibited</u>. The following will apply:

a. As necessary to maintain good haylands, control weeds and brush by mowing to a height no less than four (4) inches during the period <u>1 June through 1 September</u> each year or by

applying herbicides as approved in writing by the Real Estate Contracting Officer's or authorized representative. Mowing or brushogging, not to exceed one time per year, can be directed by the Real Estate Contracting Officer's or authorized representative. This will be at the lessee's expense.

b. Mowing for hay may be performed only during the period <u>15 June through 15 October</u> at a height of no less than 4 inches.

c. Haylands will not be plowed or broken except for improvement and only then with the written approval of the Real Estate Contracting Officer's or authorized representative. "No till drill" practices will be permitted with written approval. Annual Rye, Wheat, Korean Lespedeza, Kobe Lespedeza, Proso Millet, Big Bluestem, Little Bluestem, Gamagrass, Indiangrass, and Switchgrass are approved seed types for this practice. Other native perennial and annual grasses along with non-native annuals maybe planted with written approval.

e. Baled hay must be removed from the lease plot within 14 days of baling.

f. Any application of lime and fertilizers must be in the quantity and analysis indicated by soil test results which can be obtained upon request through the local County Extension Agent Office. If application is directed by the Real Estate Contracting Officer's or authorized representative, specific areas for application and quantities will be defined and rental credit or refund will be at the rates set out in the attached Work Items Credit Schedule (irrespective of the actual costs to the lessee). The Site Manager will be notified at least 7 days prior to application to allow a representative to witness the application. Receipts for lime and fertilizers will be furnished to the Site Manager before rental credit or refund will be accomplished. This application must also be in accordance with soil test results.

3. <u>PHOTO MAP SYMBOL - "P", PASTURE</u>. Lands marked with the symbol "P" on the photo map may be mowed for hay or grazed as pasture and the following will apply:

a. <u>Graze and/or hay only</u> as desired in any lease year; however, overgrazing will not be allowed.

b. As necessary to maintain proper pasture standards, control weeds and brush by mowing during the period <u>15 July through 1 September</u> or by applying herbicides as approved in writing by the Real Estate Contracting Officer's or authorized representative prior to application. Mowing heights will be no less than six (6) inches unless mowing is for hay production. Mowing of hay will be performed only during the periods <u>15 June through 15 October</u> at a height of no less than four (4) inches. Mowing or brushogging, not to exceed one time per year, can be directed by the Real Estate Contracting Officer's or authorized representative. This will be at the lessee's expense.

c. Any application of lime and fertilizer must be in the quantity and analysis indicated by soil test results which can be obtained upon request through the local County Extension Agents Office. If application is directed by the Real Estate Contracting Officer's or authorized

representative, specific areas for application and quantities will be defined and rental credit or refund will be at the rates set out in the attached Work Items Credit Schedule (irrespective of the actual costs of the lessee). The Site Manager will be notified at least 7 days prior to application to allow a representative to witness the application. Receipts for lime and other fertilizers will be furnished to the Site Manager before rental credit or refund will be accomplished. The lessee may choose to apply lime and fertilizer at the lessee's expense. This application must also be in accordance with soil test results.

d. These lands will not be plowed or broken except for pasture improvement and only then with the written approval of the Real Estate Contracting Officer's or authorized representative. "No till drill" practices can also be permitted with prior written approval.

4. <u>PHOTO MAP SYMBOL - "R", RANGE GRAZING</u>. Lands marked with the symbol "R" on the photo map are best suited for range grazing due to slope, soil type, or past treatment. Improved grasses and clovers can be established upon written approval by the Real Estate Contracting Officer's or authorized representative. No rental credit or refund will be made for brush removal and establishment of grasses and/or clovers on parcels designated "R" on the photo map. Brushogging of "R" areas is required every alternate year between <u>15 July and 1</u> <u>September</u> at a height of no less than 4" beginning in 2022, and every other year thereafter at the expense of the lessee. No mowing or brushogging in the interim years will be allowed. The following is table indicates the "R" brushogging schedule for the lease term.

\*\* "X" indicates "<u>No Brushogging</u>" of Range Areas is permitted during that year.

5. <u>PHOTO MAP SYMBOL - "F", FOREST</u>. Lands marked with the symbol "F" on the photo map are to be maintained as woodland and may be used for grazing. No cutting or clearing is permitted.

6. <u>PHOTO MAP SYMBOL - "WC", WILDLIFE COVER</u>. Lands marked with the symbol "WC" on the photo map are considered valuable as wildlife habitat and will be managed for the protection and production of wildlife. This cover strip will be separate, and in addition to, the 50' or 75' buffer strip discussed in paragraph 5, General Conditions. Cover strips shall be 50' wide and the length and location indicated on the lease plot photo map. Brushogging of "WC" areas is required between 15 July and 1 September at a height of no less than 6"in the year 2023 and every other year thereafter at the expense of the lessee. The "WC" areas must be maintained during the interim years. The brushogging expense and the loss of total field acreage should be considered by prospective lessees when preparing bids for leases requiring wildlife cover strips.

7. <u>PHOTO MAP SYMBOL- "PWC", PERMANENT WILDLIFE COVER.</u> Lands marked with the symbol "PWC" on the photo map are considered valuable as wildlife habitat and will be managed for the protection and production of wildlife. These native vegetation strips will be a minimum of 100' in width and may not be mowed or manipulated in any way. Failure to maintain the "PWC" areas is grounds for lease cancellation.

8. PHOTO MAP SYMBOL - "WFS", WILDLIFE FOOD STRIP. Lands marked with the symbol "WFS" on the photo map will be established as food strips for wildlife at the sole expense of the lessee. This expense should be considered by prospective lessees when preparing bids for leases requiring food strips. The lessee shall prepare food strips for planting and apply lime and fertilizer in the quantities and of the analysis indicated by soil test results available at the local County Extension Agents Office. Food strips will be a minimum of four standard full rows, broadcast, or drilled in a 12-foot minimum strip. Plant the length of the designated "WFS" each year between April through June for the spring food strips and September through October for the fall food strips. If preferred by the lessee, "WFS" maybe planted in the fall rather than spring at the expense of the lessee. During the fall, food strips maybe disk, tilled, or drilled using the same specification in site preparations and width as the spring food strips. The lessee may select a seed from the attached list of wildlife food strip grain selections for the fall food strips, or, with the exception of cotton or melons, it may be the same as crop that are present for the spring food strips. In the spring "WFS" will be planted at the same time as the main crop. In the event of unfavorable soil conditions or high water in the "WFS" area, the lessee will allow the 12-foot minimum "WFS" to adjoin the outer edge of the main crop area at the time the main crop is planted. If planting the main crop cannot be performed by the end of June due to high water or unfavorable soil conditions, a fall "WFS" will be planted in September. "WFS" crops may not be harvested by the lessee and the areas may not be tilled until 15 March of the following year.

9. <u>PHOTO MAP SYMBOL - "WIA", WILDLIFE IMPROVEMENT AREA</u>. Lands marked with the symbol "WIA" on the photo map will be established as food plots for wildlife at the sole expense of the lessee. This expense should be considered by prospective lessees when preparing bids for leases requiring food plots. Wildlife Improvement Areas shall be disked and broadcasted using either Proso Millet or Winter Wheat. In the spring, Proso Millet shall be disked and sown each year between the dates of April 1 and July 1 at a rate of 30 lbs per acre OR plant in the fall, Winter Wheat shall be disked and sown each year between the dates of <u>September 1 and</u>

November 1 at a rate of 100 lbs per acre. Millet maybe harvested for hay each year before the next planting season.

9. <u>PHOTO MAP SYMBOL - "NT", NO TREATMENT</u>. Land marked with the symbol "NT" on the photo maps are designated as no treatment areas. No cutting, clearing or grazing is allowed.

10. <u>PHOTO MAP SYMBOL - "DL" DIVERSION LEVEE LANDS</u>. Lands marked with the symbol "DL" on the photo map may be used for hay production only. Livestock grazing is prohibited. "DL" Diversion Levee Lands will not be plowed or broken. The following will apply:

a. A mandatory 100% mowing of all "DL" Diversion Levee Lands is required each year between 15 August and 30 September. This will be at the lessee's expense.

b. The area of the levee and berms will be maintained in perennial grass such as Bermuda grass. Mowing heights will be no less than four (4) inches and no more than six (6) inches.

c. Mowing for hay production will be performed during the period of 15 May through 30 September. Baled hay must be removed from the lease plot within 14 days of baling.

d. The location and design of fences, gates, cattle guards, berms, ditches, and ramps must be approved in writing by the Site Manager prior to installation.

e. Any application of lime and fertilizers must be in the quantity and analysis indicated by soil test results which can be obtained upon request through the local County Extension Agent Office. If application is directed by the Real Estate Contracting Officer's or authorized representative, specific areas for application and quantities will be defined and rental credit or refund will be at the rates set out in the attached Work Items Credit Schedule (irrespective of the actual costs to the lessee). The Site Manager will be notified at least 7 days prior to application to allow a representative to witness the application. Receipts for lime and fertilizers will be furnished to the Site Manager before rental credit or refund will be accomplished. This application must also be in accordance with soil test results.

f. As necessary to maintain good haylands, herbicide application for weed and brush control may be performed as approved in writing by the Real Estate Contracting Officer's or authorized representative. This will be at the lessee's expense.

# LANDS USE REGULATIONS - WORK ITEMS CREDIT SCHEDULE

Work to be performed under this Schedule shall not exceed the five year cash rental consideration. The work may include, but is not limited to, the application of lime and fertilizers, the planting of cover crops, boundary and interior fencing, discing and brushogging, and performing miscellaneous farm management practices. The Real Estate Contracting Officer's or designated representative will direct, in writing, the work to be performed including the exact location, quantity, and the time frame. No work under the Work Items Credit Schedule is to be performed prior to receiving written approval from the Real Estate Contracting Officer's or designated representative.
