- **B.** Typical year assessment(s): The assessment was based on the Corps site visits conducted on August 21, and November 4, 2020.
- C. Additional comments to support AJD: The Corps November 4 site inspection and stream assessment was conducted only three days after a 6-inch rain event. Despite the recent heavy precipitation, the ephemeral channel across the project site did not have any flowing water. The upstream half still had a few pockets of standing water, but the downstream half was completely dry with vegetation growing across

the channel bed, further indicating that the channel only supports flows in direct response to storm events. During the August 21 site inspection, the channel had similar conditions, but with fewer standing water pockets and much drier conditions due to a recent period with only minimal rainfall during the late summer.
