C. Additional comments to support AJD: Ditch-01, a road side ditch constructed in uplands, abuts Wetland 02, Wetland 03, and Wetland 04. Wetland-01 is located nearby the ditch, but does not abut Ditch-01. Because Ditch-01 ((b)(4) water) is not a water of the U.S., the associated wetlands would not be regulated (non-adjacent wetlands).
