Centrally located in the proposed project area is a man-made farm pond (Pond C; < 0.5-acre). This feature is isolated and likely does not convey surface flow to jurisdictional waters. #### B. ADDITIONAL COMMENTS TO SUPPORT JD:

In summary, it was determined that there were three aquatic features in the proposed project area. A man-made roadside ditch (1,138 linear feet) that is non-jurisdictional based on Rapanos guidance, a man-made upland farm pond that is excluded and not considered as jurisdictional waters according to the November 13, 1986, Federal Register (51 FR, 41217), and 0.06 acres of isolated, emergent wetlands, which based on field inspection and desktop evaluation, does not exhibit a connection to jurisdictional waters.
