B. REQUIRED ADDITIONAL COMMENTS TO SUPPORT JD. EXPLAIN RATIONALE FOR DETERMINATION THAT THE REVIEW AREA ONLY INCLUDES DRY LAND: The project site contains only uplands and consists mostly of an open field that is mowed often. Stormwater runoff on the site flows overland and is collected in a culvert running under Sunshine Street and then into an erosion swale north of the project site. The Corps concurs with the field delineation and report submitted by the project consultant which did not identify any wetlands or streams on the property. The Little Rock District performed a previous jurisdictional determination for this site in February 2000, and determined that the site did not contain any waters of the U.S. There have been no major changes to the site since that previous determination.



