Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: A 0.6-acre wetland was identified on the White Bluff Electric Facility, which has had significant alterations to other waters of the United States (WOTUS) through channelization of streams into drainage ditches. The wetland met the criteria in the 1987 Corps of Engineers Wetland Delineation Manual and appropriate Regional Supplements but lacked a significant nexus to any TNW. The wetland

B. Characteristics of Tributary (That Is Not a TNW) and Its Adjacent Wetlands (If Any):

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The wetland was probably historically connected to other WOTUS by a stream named Lipscomb Creek located on the facility. However, this stream and other streams on the facility has been extensively altered to provide drainage at the facility and to direct water flow into the "Surge Pond" located on the facility. Therefore, although the wetland meets the criteria in the 1987 Corps of Engineers Wetland Delineation Manual and appropriate Regional Supplements, it lacks a significant nexus to any other WOTUS including a TNW.
