It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its

B. ADDITIONAL COMMENTS TO SUPPORT JD: CEC, Inc. identified one emergent wetland feature in their wetland delineation of the approximately 9.7-acre subject property. This feature was located in the western end of an abandoned coal mine pit. CEC's wetland delineation, in addition to aerial photography, NHD data, and USGS topographic quadrangle Huntington, AR, documents the upland setting of the subject property. The wetland delineation and related resources clearly document the absence of waters of the U.S. within the subject property. In summary, the mine pit was constructed in uplands (circa 1960s to 1970s) and later abandoned, supporting no hydrologic connection to waters of the U.S.
