C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its

B. ADDITIONAL COMMENTS TO SUPPORT JD: A man-made pond (Pond 2) was identified by Crafton Tull as a man-made pond constructed in uplands. A Corps site visit and AJD in 2021 confirmed this determination. The delineation by Crafton Tull identified emergent wetlands that bordered the pond; however, a Corps site visit indicated these wetlands were within the pond's constructed banks and would not be considered fringe wetlands. The pond fits the criteria of waters generally not considered waters of the U.S. as identified in the preamble of the November 13, 1986, Federal Register (51 FR, 41217), and therefore would not be regulated under Section 404 of the Clean Water Act.
