- **B.** Typical year assessment(s): ATP was accessed for period corresponding to Crafton Tull's field visit. Findings: wet season, normal conditions.
- C. Additional comments to support AJD: OW-1, a tributary to McKisic Creek, is mapped as intermittent by NHD and on USGS topographic quadrangles. FEMA flood panel 05007C0090J maps a floodway and floodplain associated with the channel. Crafton Tull's report and provided photos indicate the channel is intermittent with a well established bed/bank and pool/riffle morphology. Finally, aerial imagery accessed in Google Earth consistently shows water/flow in the channel during multiple years.
