Explain: A wetland delineation by Cattails Environmental, LLC identified two geographically isolated wetland features, PFO01 and PEM02. The first feature, PFO01 is located in the northwestern portion of the subject property and represents a forested wetland feature that appears man-made (shallow pond with berm). A vague drainage pattern exits the feature and transitions to broad uplands currently utilized as a sod farm. The second feature, PEM02, is an emergent wetland located in the southwestern portion of the subject property and in an area currently a sod farm. This feature is a relict swale feature that is geographically isolated and does not

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands,

has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: A wetland delineation by Cattails Environmental, LLC identified two geographically isolated wetland features, PFO01 and PEM02. A Corps site visit on April 10, 2023, confirmed the location and geographically isolated nature of the features. The first wetland feature, PFO01, totals approximately 0.03 acre, and represents a small, forested area that was likely man-made (subtle evidence of berming was observed during the Corps site visit). A vague drainage pattern exits the feature and transitions to broad uplands that are currently utilized for sod farming. The second feature, PEM02, totaling approximately 0.20 acre, is located in the southwestern portion of the subject property. Similar to PFO01, there was no surface hydrologic connection to downslope jurisdictional waters of the U.S. (WOTUS). This feature represents a relict swale that is geographically isolated and is surrounded entirely by uplands. In summary, both features are geographically isolated and would not be regulated under Section 404 of the Clean Water Act.
