Summarize overall biological, chemical and physical functions being performed: Wetlands function as a pollution and nutrient sink, which is helpful in an industrial/commercial/residential area. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: There are two streams and three very small wetlands onsite. Tributary 1 is ephemeral and flows along the western edge of the property. There are 660 linear feet of Tributary 1 located onsite. Tributary 2 flows along the eastern edge of the site, but only approximately 135 linear feet of this intermittent stream are located on the property. Wetland 1 (approximately 50 square feet) is a narrow drainage swale that flows directly into Tributary 1. Wetlands 2 (50 square feet) and 3 (250 square feet) are small depressional areas in the wooded portion of the southern end of the property.
