This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e., tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). C. **SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Ephemeral Stream A is a jurisdictional stream that flows from south to north and is approximately 87 linear feet within the site. This stream is an unnamed tributary to Whig Creek and flows thru a small wetland area outside of the review area. Minor flow, moderate sediment sorting, and a weakly-defined bed and bank were noted at the time of the site visit.

Ephemeral Stream C is a jurisdictional stream that flows from east to west and is approximately 181 linear feet within the site. This stream is an unnamed tributary to Whig Creek showing defined bed and banks with minor flow during site visit.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Project area contains upland sites as well as jurisdictional wetlands and streams. The historical aerial imagery confirms frequent inundation of the wetland area and flow regime of the jurisdictional stream channels. Site visit occurred shortly after a recent rainfall event and definitely helped define jurisdictional status and boundaries.
