B. Characteristics of Tributary (That Is Not a TNW) and Its Adjacent Wetlands (If Any):

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e., tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that directly abuts an RPW is also jurisdictional. If the aquatic resource is not a TNW, but has year-round (perennial) flow, skip to Section III.D.2. A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: A wetland delineation by PMI identifies a channel along the western boundary of the subject property flows north and turns east along the northern boundary of the subject property. The PMI wetland delineation defines the channel as perennial; however, aerial photography (Google Earth) based on several years of record indicate the channel exhibits seasonal flow. Two additional channels (tributaries to Int-A) were identified within the PMI wetland delineation, located in the northern portion of the subject property. Each of these channels (Int-B and Int-C) support a short reach, however, they exhibit well-defined bed/banks and supported moderate flow during the PMI field investigation. LiDAR data further indicates well-defined banks within both channels. Based on aerial photography and photos provided by PMI, both channels appear to support intermittent flow, likely the result of groundwater influence (both are located in an area that could have been the original channel or channel braid of Int-A), in addition to surface runoff.
