Explain: A wetland delineation by Crafton Tull (Agent) identified a man-made pond and three emergent wetlands (Wetlands 1-3) that are surrounded by uplands and geographically isolated. A previous AJD (SWL-2021-00305) that included northern portions of the subject property, identified the pond as a man-made feature constructed in uplands. A site visit confirmed the three emergent wetlands areas were geographically isolated, lacking a hydrologic connection to waters of the U.S.

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e., tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that directly abuts an RPW is also jurisdictional. If the aquatic resource is not a TNW, but has year-round (perennial) flow, skip to Section III.D.2. A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. Corps districts and EPA regions will include in the record any available information that documents the existence of a significant nexus between a relatively permanent tributary that is not perennial (and its adjacent wetlands if any) and a traditional navigable water, even though a significant nexus finding is not required as a matter of law.

(iii) Chemical Characteristics:

- Habitat for:

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: A wetland delineation by Crafton Tull identified an intermittent channel (Intermittent Tributary 1), a man-made pond (Pond 1), and three emergent wetland areas (Wetlands 1-3) within the approximately 77-acre subject property. The intermittent channel (a tributary to Puppy Creek), which flows along portions of the eastern, western, and northern perimeter of the subject property, represents a RPW (a tributary to Spring Creek and Illinois River, a TNW), therefore this feature is jurisdictional under Section 404 of the CWA. A previous AJD completed in 2021 (SWL-2021-00305) identified the man-made pond as isolated, being constructed in uplands. Wetland 1, a remnant of a man-made farm pond (that was dry during the Corps site visit), is located in uplands. Wetlands 2 and 3 are small depressions, surrounded by uplands, that are geographically isolated. In summary, Wetlands 1-3 and Pond 1 are isolated features that lack a hydrologic connection to regulated waters of the U.S., therefore, they would not be regulated under Section 404 of the CWA.
