Summarize overall biological, chemical and physical functions being performed: These forested wetlands serve as flood attenuation, sediment trapping, improved Water Quality, ground water recharge, and wildlife diversity.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: W1 is completely surrounded by a berm with no apparent connection to an RPW or W2. W2 & W3 appear to be connected only by flooded fields/sheet flow. W4 has a berm around it and directly abuts an RPW in the SW corner. W3 flows south through a small swale but is stopped at the northern side of W4 by a levee and there appears to not be any connection between the two wetlands. Field data indicates that these two wetlands are isolated and do not have any connections to an RPW. There is a channelized ditch/swale in the lower SW side of W4 that connects to another ditch which flows south to southwest finally connecting to Goose Pond Slough (RPW) and then into the White River (TNW). The three smaller wetlands (W5, W6, W7) all are interconnected by ditches/swales and ultimately a channelized ditch which flows south southwest into Goose Pond Slough then into the White River. This connection is thru a culverted

connection and a small valley area next to the channelized ditch. Additionally, in the NE portion of these wetlands the channelized ditch connects to the ditches running thru these wetlands. W8 is isolated in the SW corner of the review area and appears to have no connection to an RPW.
