- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.
Explain: The Corps conducted a site visit to verify the wetland delineation by David Fowlkes. The 3.1 acres of palustrine forested wetlands were verified within the review area and sit on a naturally elevated plateau. However, these wetlands are outside the 100-year floodplain. In 2017, the area had an estimated 300-year flood event, and the water level from the Current River did not reach the area. The wetland feature does not have a surface connection to any jurisdictional water of the U.S and is isolated.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its

adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: USGS topographic maps identify the area as a small plateau and do not identify the area historically as a wetland. FEMA floodplain maps show the area as outside the 100-year floodplain, and in 2017 the area had an estimated 300-year level flood event. The estimated +33 foot water levels during this event were over 3,000 feet away (measured on Google Earth) from the above delineated wetland. Aerial imagery from google earth shows the area has primarily prior converted cropland, and there are no historical surface connections.
