Explain: Three features were identified by PMI and during the Corps site visit, including: an erosional feature (lacking an OHWM), a man-made pond constructed in uplands, and a channel (exhibiting a discontinuous OHWM) that enters/exits the pond before transitioning to upland sheet flow. None of the described features are jurisdictional under Section 404 of Clean Water Act.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its

adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The PMI wetland delineation and Corps site visit revealed three features within the approximately 20-acre subject property. An ephemeral channel (Ephemeral Channel A) that lacks a defined bed/bank, but exhibited discontinuous OHWM indicators, was observed that flowed west toward a man-made pond. The channel exits the pond and transitions to upland sheet flow, terminating in an upland area just west of the pond. The channel and pond are geographically isolated from potentially regulated waters of the U.S. In addition, an erosional feature (Ephemeral Channel B) located near the north-central property boundary, indicated on the PMI report as "Non-Jurisdictional Ephemeral Stream B," is an upland erosional drain lacking an OHWM. In summary, none of the three identified features would be regulated as waters of the U.S. under Section 404 of the Clean Water Act.
