Explain: The project area is located just east of an area of a residential development and consist of undeveloped improved pasture/hayfield. The project area is generally level. An ephemeral channel is located in the eastern portion of the project area and two man-made ponds are located in the central portion of the project area. One potential wetland area is abutted to the northern most man-made

pond in the central portion of the project area. The wetland and associated pond are located in uplands and lack a direct connection to regulated waters. A faint swale is observed, both on aerial images and during the consultant's (FTN and Associates, Ltd) field observations, just north of the pond. This swale is dominated by upland vegetation and eventually becomes indiscernible toward the northern portion of the project. For these reasons the waters are considered isolated.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Aerial imagery going back to 1994 showed no previous hydrologic connection to waters of the United States and show no substantial nexus to interstate or foreign commerce. The waters are geographically isolated and are therefore non-jurisdictional isolated waters.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The potential waters of the United States were found to be unregulated isolated waters primarily due to their lack of any hydrologic connection to any jurisdictional waters of the United States. Multiple-year aerial imagery and on-site field observations (photos) by the consultant (FTN and Associates, Ltd) provided unmistakable evidence for the non-jurisdictional isolated characteristics of the ponds, wetland, and ephemeral stream located on the project area.
