OW-1 is a pond constructed in an upland that receives surface flow via sheet flow through UPL-1 and passes sheet flow via UPL-2. UPL-3 conveys sheet flow from WET-B, however, it terminates at the road along

the southern project boundary. There are no culverts or defined bed and bank features that allow for a connection to the RPW to the south. UPL-4 lacks any defined bed or bank nor has any connection to the RPW to the south of the project boundary.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION**

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands,**

has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

UPL-1 (243 linear feet), UPL-2 (301 linear feet), UPL-3 (166 linear feet), UPL-4 (811 linear feet) are non-regulated swales lacking a defined bed or bank. OW-1 is a pond constructed in an upland that receives surface flow via sheet flow through UPL-1 and passes surface flow via sheet flow through UPL-2. WET-B is located between UPL-2 and UPL-3 but has no apparent connection to an RPW. UPL-3 terminates at the road along the southern project boundary, there were no culverts or defined bed and bank features to allow for a connection to the RPW to the south. UPL-4 lacks any defined bed or bank nor has any connection to the RPW to the south of the project boundary.
