Explain: A wetland delineation by Crafton Tull (agent) identified five wetlands, five ephemeral channels, and two man-made ponds within the approximately 116-acre subject property. A channelized feature (identified as Wetland 1, Wetland 5, and Ephemeral 1 in a wetland delineation by Crafton Tull) enters the northwest portion of subject property and flows south/southeast. The upper reaches of the feature supports wetland characteristics (Wetland 1 and 5); below Wetland 5 the feature transitions to a swale (lacking an OHWM). As the channel (Ephemeral 1) flows south through the property it enters a pond (Pond 2) and just south of the pond

supports a short reach that exhibited indicators of an OHWM before transitioning to an upland swale (lacking an OHWM) and eventually transitioning to overland sheet flow just before exiting the subject property. Three additional ephemeral channels (Ephemeral 3, 4, and 5) lacking an OHWM were identified in the southeastern portion of the subject property and one short reach of ephemeral channel (Ephemeral 6) was identified in the northwestern portion. These features lack an OHWM (representing upland swales), and therefore do not qualify for jurisdiction under Section 404 of the Clean Water Act. Three wetland areas, Wetlands 1, 2, and 5, were identified in the northwestern portion of the subject property. Wetlands 1 and 5 represent linear wetland features associated with a channelized feature (identified as Ephemeral 1 further downstream). Wetland 2 (an emergent and shrub/scrub wetland area totaling approximately 2.27-acres) is located adjacent to (but does not abut) Wetland 1 (Ephemeral 6 exits Wetland 2 and enters Wetland 1). A man-made pond constructed in uplands (Pond 1) lies adjacent to Wetland 2 in the northwestern portion of the subject property. An additional pond (Pond 2) is located in the central portion (adjacent to Ephemeral 1) of the subject property. In summary, Wetlands 1, 2, 5, and Ponds 1 and 2 are adjacent to Ephemeral 1; however, Ephemeral 1 is not a regulated water and transitions to upland sheet flow within the subject property. Therefore, the wetland and pond features listed above lack hydrologic connection to a RPW or a TNW (Illinois River) and are effectively geographically isolated. Finally, two additional emergent wetlands (Wetlands 3 and 4) located along the western property boundary are geographically isolated (surrounded entirely by uplands).

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

and exhibits infrequent (likely only a few events per year) surface flow, transitioning to a poorly defined swale before exiting the subject property as upland sheet flow. Four additional ephemeral channels; Ephemeral 3 (65 linear feet), Ephemeral 4 (128 linear feet), Ephemeral 5 (265 linear feet), and Ephemeral 6 (11 linear feet) all lack an OHWM.

B. ADDITIONAL COMMENTS TO SUPPORT JD: A wetland delineation was conducted by Crafton Tull in May 2022 and a subsequent site visit and addendum completed by Crafton Tull in August 2022. The wetland delineation and addendum identified five wetland features (Wetlands 1-5), two man-made ponds (Ponds 1 and 2), and five ephemeral channels lacking an OHWM (Ephemeral 1, 3, 4, 5 and 6). Ephemeral 1 enters the northwest portion of subject property as a channelized ditch feature (identified as Wetland 1 and 5 in Crafton Tull’s delineation and the attached maps) and flows south/southeast. South of Wetland 5 the channel is poorly defined and lacks an OHWM (exhibiting swale characteristics); as it continues south it enters and exits a man-made pond (Pond 2). Immediately downstream (southeast) of the pond it supports a short reach that exhibited indicators of an OHWM before transitioning to an upland swale (lacking an OHWM) and eventually transitioning to overland sheet flow just before exiting the subject property. Three additional ephemeral channels (Ephemeral 3, 4, and 5) lacking an OHWM were identified in the southeastern portion of the subject property and one short reach of ephemeral channel (Ephemeral 6) was identified in the northwestern portion. These features lack an OHWM, and therefore do not qualify for jurisdiction under Section 404 of the Clean Water Act. Three wetland areas, Wetlands 1, 2, and 5, were identified in the northwestern portion of the subject property. Wetlands 1 and 5 represent linear wetland features within a generally channelized feature that transitions to Ephemeral 1 further downstream. Wetland 2 is located adjacent to but

does not abut Wetland 1 (Ephemeral 6 exits Wetland 2 and infrequently discharges into Wetland 1). A man-made pond constructed in uplands (Pond 1) lies adjacent to Wetland 2 in the northwestern portion of the subject property. As mentioned previously, an additional pond (Pond 2), is located in the central portion (adjacent to Ephemeral 1) of subject property. In summary, Wetlands 1, 2, 5; and Ponds 1 and 2 are adjacent to Ephemeral 1; however, Ephemeral 1 is not a regulated water and transitions to upland sheet flow within the subject property. Therefore, these wetland and pond features lack hydrologic connection to a downstream RPW or TNW (Illinois River) and are effectively geographically isolated. In addition, two emergent wetlands (Wetlands 3 and 4) located along the western property boundary are geographically isolated (surrounded entirely by uplands and lacking a hydrologic connection to any waters of the U.S.). Therefore, the identified features, due to their geographic isolation, would not be regulated as waters of the U.S. under Section 404 the Clean Water Act.
