Explain: Terracon (Agent) identified two man-made ponds (Pond A and B) and associated adjacent wetlands (Wetlands A and B) within the subject property. These features are surrounded by uplands (lacking a hydrologic connection to potentially regulated waters) and geographically isolated. In addition, an upland swale was observed between the ponds and downstream of Pond A; however, this feature lacks an OHWM and transitions to upland sheet flow shortly after exiting the subject property.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its

adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: A Corps site visit on August 23, 2022, confirmed the findings provided by Terracon identifying two man-made ponds (Pond A and B) and adjacent/fringe wetlands (Wetland A and B) as geographically isolated features. Terracon also identified a swale/erosional feature that originates just east of Pond B and becomes slightly more defined between Ponds A and B, exiting Pond A as a vegetated swale (lacking an OHWM) before exiting offsite. This feature lacks indicators of an OHWM and transitions to upland sheet flow approximately 500 linear feet west/northwest of the subject property. The man-made ponds and associated wetlands lack hydrologic connection to regulated waters, and therefore would not be regulated under Section 404 of the Clean Water Act. The swale feature lacks an OHWM and represents a non-regulated preamble water.
